

RESOLUTION NO. R-552-14

RESOLUTION RENAMING LEISURE LAKES PARK AS
"LIVE LIKE BELLA PARK"

WHEREAS, Bella Rodriguez-Torres was only four years old when she suddenly became paralyzed overnight and diagnosed with stage four cancer; and

WHEREAS, Bella Rodriguez-Torres was believed to never again walk and had a life expectancy of only a few months; and

WHEREAS, Bella Rodriguez-Torres demonstrated great bravery and faith and regained the ability to walk, run, and jump and inspirationally fought her disease for almost six years; and

WHEREAS, Bella's life and journey inspired our community and people all around the world to live courageously; and

WHEREAS, Bella's life and legacy have brought great awareness to pediatric cancer and the necessity for greater research and support; and

WHEREAS, this Board would like to recognize Bella Rodriguez-Torres' bravery and lasting contribution to our community by renaming Leisure Lakes Park as "Live Like Bella Park"; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed naming, renaming or codesignation of Miami-Dade County roads, facilities or property shall be sponsored by the district commissioner where the road, facility or property is located; and

WHEREAS, this codesignation is located in County Commission District 8,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, renames Leisure Lakes Park as "Live Like Bella Park".

Section 2. Directs the Mayor or designee to revise all references to Leisure Lakes Park to "Live Like Bella Park", and to install suitable signage to reflect the renaming.

The Prime Sponsor of the foregoing resolution is Vice Chair Lynda Bell. It was offered by Commissioner **Lynda Bell**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
