RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE MARCH 15, 2014 "RELAY FOR LIFE MIAMI SPRINGS, VIRGINIA GARDENS AND MEDLEY 2014" EVENT SPONSORED BY THE AMERICAN CANCER SOCIETY, INC. IN AN AMOUNT NOT TO EXCEED \$910 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 6 FY 2013-14 IN-KIND RESERVE FUND

WHEREAS, the "Relay for Life Miami Springs, Virginia Gardens and Medley 2014" event is a special event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$ 910.00 of the in-kind services shall be funded from the balance of the District 6 FY 2012-13 In-Kind Reserve Fund,

The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:

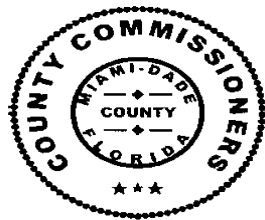

all to share in their journeys and recovery.



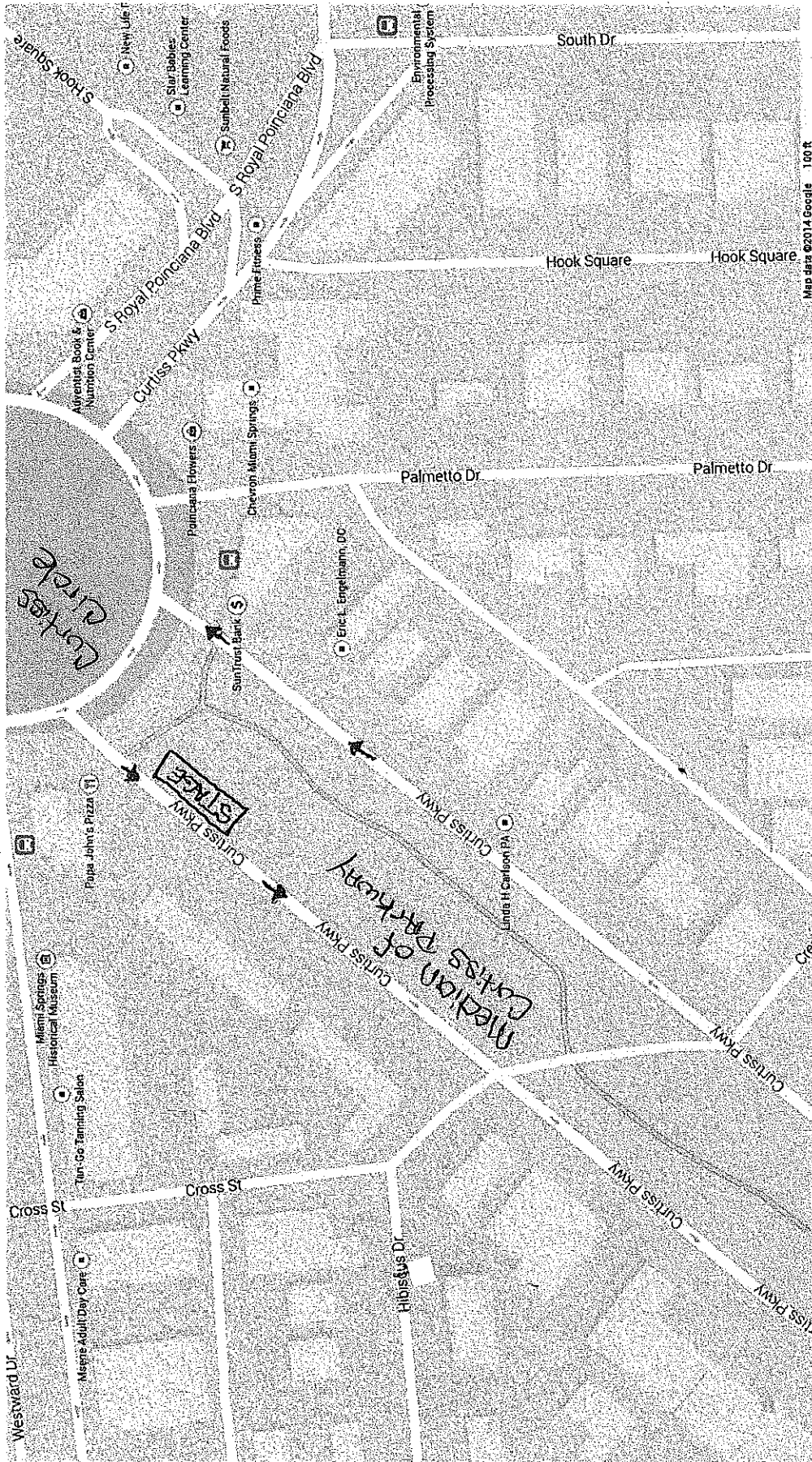
