

RESOLUTION NO. R-683-14

RESOLUTION AUTHORIZING CERTAIN SETTLEMENT IN THE AMOUNT OF \$20,000.00, IN COUNTY EMINENT DOMAIN PROCEEDINGS BY COUNTY ATTORNEY IN CONNECTION WITH THE ACQUISITION OF LAND REFERRED TO AS PARCEL 3, FOR THE RIGHT-OF-WAY NEEDED FOR IMPROVEMENTS TO SW 176TH STREET FROM US 1 TO 107TH AVENUE AND AUTHORIZING THE USE OF CHARTER COUNTY TRANSPORTATION SURTAX FUNDS

WHEREAS, this Board by Resolution No. R-736-10 dated July 8, 2010, previously declared the acquisition of land for the right-of-way needed for road widening, beautification, and right-of-way improvements to SW 176th Street from US 1 to SW 107th Avenue to be a public necessity and authorized the acquisition of land therefore by eminent proceedings; and

WHEREAS, the owner of Parcel 3, as set forth in the attached land acquisition summary sheet, has offered to settle for the figure specified therein; and

WHEREAS, this project is being funded by the use of Charter County Transportation Surtax Funds, and this settlement thus must be submitted for the review and recommendation of the Citizens Independent Transportation Trust; and

WHEREAS, the County Attorney hereby recommends the settlement amount as set forth in the attached Land Acquisition Summary sheet,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board ratifies and adopts the matters set forth in the foregoing recitals.

Section 2. This Board authorizes the County Attorney to compromise and settle on behalf of the County all claims against the County in eminent domain proceedings for Parcel 3 in the amount specified in the attached land acquisition summary sheet, and authorizes the use of Charter County Transportation Surtax Funds.

Section 3. Pursuant to Resolution No. R-974-09, the Board directs the County Mayor or County Mayor's designee to record any instrument of conveyance accepted herein in the Public Records of Miami-Dade County, Florida; and to provide a recorded copy of the instrument to the Clerk of the Board within thirty (30) days of execution of said instrument; and directs the Clerk of the Board to attach and permanently store a recorded copy together with this resolution.

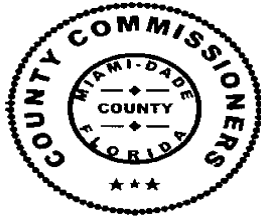
The foregoing resolution was offered by Commissioner **Lynda Bell**,

LAND ACQUISITION SUMMARY SHEET

PROJECT: Roadway expansion, beautification, and right of way improvements to SW 176th Street from US 1 to SW 107th Avenue in Miami-Dade County, Florida.

PARCEL NUMBER AND PROPERTY ACQUIRED: Parcel No. 3 (Fee Simple) 134 square feet (See attached sketches in Exhibit B).

OWNERSHIP INTEREST: Georgia M. Cooper and Arthur L. Cooper (deceased), through Arthur Cooper, Jr.

COUNTY'S APPRAISAL AND DAMAGES: \$16,900.00
Patrick Mikus, ASA

OWNER'S ESTIMATE OF VALUE: \$ 20,000.00.

SETTLEMENT AMOUNT: The total settlement amount is \$20,000.00. (See Comments below – this amount includes any owner's attorneys' fees, costs, site development fees, and expert fees).

POTENTIAL EXPOSURE TO COUNTY: \$3,100 (difference between owner's estimate of value and County's appraisal), plus potentially additional costs and attorneys fees.

COMMENTS: A proposed settlement was reached in the amount stated above. In order for the County to obtain clear title to this parcel, eminent domain proceedings had to be instituted. The settlement amount of \$20,000.00, represents full compensation for the parcel acquired.

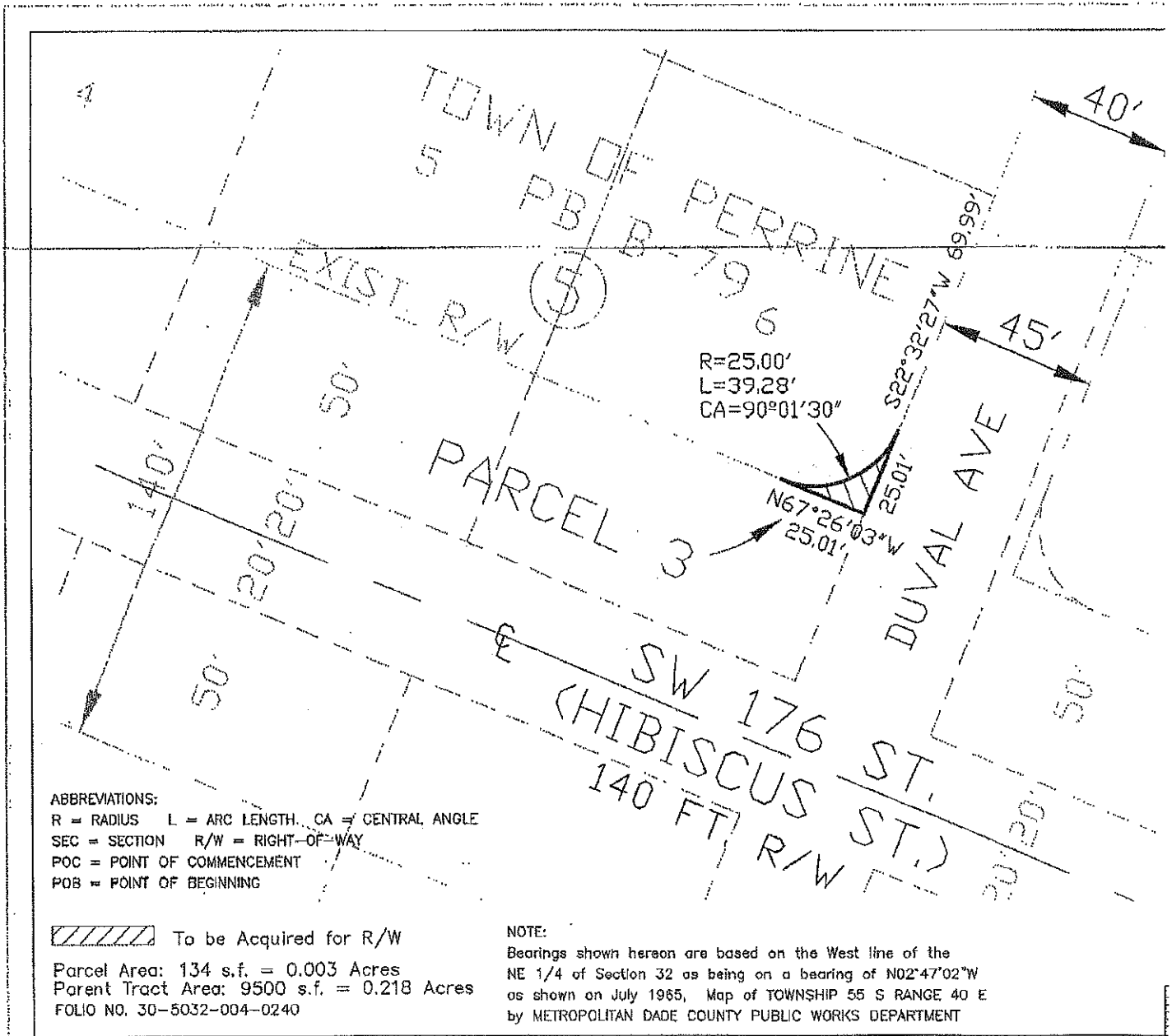
Parcel 3 – Legal Description

A portion of Lot 6, Block 5, TOWN OF PERRINE, according to the Plat thereof, as recorded in Plat Book B at Page 79 of the Public Records of Miami-Dade County, Florida; being more particularly described as follows:

The external area formed by a 25 foot radius circular curve tangent to the Northerly line of the Southerly 50.00 feet of said Lot 6 and the Easterly line of said Lot 6.
