RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE MAY 17, 2014 "HAITIAN COMPAS FESTIVAL" SPONSORED BY THE CENTER FOR HAITIAN STUDIES INC. IN AN AMOUNT NOT TO EXCEED \$7,455.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 2 FY 2013-14 IN-KIND RESERVE FUND

WHEREAS, the Center for Haitian Studies, Inc. has requested in-kind services from the Parks, Recreation and Open Spaces Department for the May 17, 2014 "Haitian Compas Festival" in an amount not to exceed \$7,455.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Haitian Compas Festival" is to celebrate the Haitian culture during day-long festivities featuring, among other things, Haitian and Caribbean musicians; and

WHEREAS, the Center for Haitian Studies, Inc. is a not-for profit organization; and

WHEREAS, the "Haitian Compas Festival" is a special event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$7,455.00 of the in-kind services shall be funded from the balance of the District 2 FY 2013-14 In-Kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Parks, Recreation and Open Spaces Department for the May 17, 2014 "Haitian Compas Festival" sponsored by the Center for Haitian Studies, Inc. in an amount not to exceed \$7,455.00 to be funded from the balance of District 2 FY 2013-14 In-Kind Reserve Fund.


