Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north by SW 288 Street, on the east approximately 450 feet west of SW 187 Avenue, on the south approximately 870 feet north of SW 292 Street, and on the west approximately 375 feet east of SW 189 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located within the boundaries of Commission District 8, Commissioner Lynda Bell.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$350.00 per year for the annual maintenance cost of that portion of SW 188 Court and SW 288 Street once the roads are constructed adjacent to and within the project which will be funded through PWWM General Fund allocation.

Track Record/Monitor

RER, Development Services Division administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

- That the Street and Court, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual

use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.

- That the use of individual wells for drinking or culinary purposes will not be permitted within this subdivision after water lines from an approved central water system are available, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

Developer's Obligation

- Paving, drainage and monumentation. Bonded under bond number 7903 in the amount of \$12,320.00.

RESOLUTION APPROVING THE PLAT OF KATES ESTATES, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 2, TOWNSHIP 57 SOUTH, RANGE 38 EAST (BOUNDED ON THE NORTH BY SW 288 STREET, ON THE EAST APPROXIMATELY 450 FEET WEST OF SW 187 AVENUE, ON THE SOUTH APPROXIMATELY 870 FEET NORTH OF SW 292 STREET, AND ON THE WEST APPROXIMATELY 375 FEET EAST OF SW 189 AVENUE)

WHEREAS, Sarlam USA, Inc. a Florida corporation, and Henry L. Willis and Chong Willis, husband and wife, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as KATES ESTATES, the same being a subdivision of a portion of land lying and being in the Southeast 1/4 of Section 2, Township 57 South, Range 38 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.
