RESOLUTION DECLARING SEPTEMBER 2014 PEDIATRIC
CANCER AWARENESS MONTH

WHEREAS, pediatric cancer (childhood cancer) is the leading cause of disease-related death among children and adolescents (ages 1 to 19 years) in the United States; and

WHEREAS, the causes of pediatric cancer are not well understood; and

WHEREAS, increased attention on pediatric cancer is necessary to raise awareness and funding in order to find cures for the different forms of pediatric cancer; and

WHEREAS, people all over the United States are observing the month of September 2014 as Pediatric Cancer Awareness Month to honor the children and families afflicted by these diseases and raise awareness of this devastating childhood disease; and

WHEREAS, the Board desires to show its support and solidarity with the families, friends, caregivers, medical personnel, concerned citizens and all those who provide support, help and encouragement to children and their loved ones affected by pediatric cancer by declaring September 2014 Pediatric Cancer Awareness Month,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the month of September 2014 shall be observed as Pediatric Cancer Awareness Month.
