

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE JULY 4, 2014 "FOURTH OF JULY CELEBRATION" SPONSORED BY THE CITY OF SOUTH MIAMI IN AN AMOUNT NOT TO EXCEED \$790 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 7 FY 2013-14 IN-KIND RESERVE FUND

WHEREAS, the City of South Miami has requested in-kind services from the Parks, Recreation and Open Spaces Department for the July 4, 2014 "Fourth of July Celebration" in an amount not to exceed \$790 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Fourth of July Celebration" is to celebrate Independence Day through the display of fireworks and family-friendly entertainment; and

WHEREAS, the "Fourth of July Celebration" event is a special event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$790 of the in-kind services shall be funded from the balance of the District 7 FY 2013-14 In-Kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Parks, Recreation and Open Spaces Department for the July 4, 2014 "Fourth of July Celebration" sponsored by the City of South Miami in an amount not to exceed \$790 to be funded from the balance of District 7 FY 2013-14 In-Kind Reserve Fund.
