

RESOLUTION APPROVING THE CITY OF SOUTH MIAMI
CODESIGNATION OF SW 64 AVENUE FROM SW 64
STREET TO SW 66 STREET AS "J. B. MOZELL-TOMPKINS
AVENUE"

WHEREAS, on May 20, 2014, the Mayor and City Commission of the City of South Miami adopted Resolution No. 101-14-14195, which codesignated SW 64 Avenue from SW 64 Street to SW 66 Street as "J. B. Mozell-Tompkins Avenue", in recognition of her contributions to the City of South Miami, a copy of which is attached and incorporated by reference; and

WHEREAS, Mrs. Johnnie Belle Tompkins was a member of the South Miami community for over 87 years; and

WHEREAS, in January of 2005, the City of South Miami paid tribute to Mrs. Tompkins on the occasion of her 90th birthday; and

WHEREAS, Mrs. Tompkins was also recognized by the City of South Miami as one of nine "unsung hero" pioneers, for her grassroots efforts throughout her years of dedicated commitment to the community; and

WHEREAS, Mrs. Tompkins brought joy and inspiration throughout her lifetime, and love to all her children and everyone she came in contact with; and

WHEREAS, Mrs. Tompkins passed away recently, and this Board would like to join the City of South Miami in recognizing her contributions to the community; and

WHEREAS, SW 64 Avenue from SW 64 Street to SW 66 Street is a city street located in the City of South Miami; and

WHEREAS, the City of South Miami wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, this codesignation is located in County Commission District Seven (7),

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of South Miami codesignation of SW 64 Avenue from SW 64 Street to SW 66 Street as "J. B. Mozell-Tompkins Avenue."

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of South Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the City of South Miami Police Department, and the Miami-Dade Fire Rescue Department.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF SOUTH MIAMI, FLORIDA:

Section 1. The Mayor and City Commission of the City of South Miami, Florida hereby name that portion of S.W. 64th Avenue, from S.W. 64th Street to S.W. 66th Street as "J. B. Mozell-Tompkins Avenue".

Section 2. Severability. If any section clause, sentence, or phrase of this resolution is for any reason held invalid or unconstitutional by a court of competent jurisdiction, the holding shall not affect the validity of the remaining portions of this resolution.

Section 3. Effective Date. This resolution shall become effective immediately upon adoption by vote of the City Commission.
