RESOLUTION NO. R-1082-14

RESOLUTION DIRECTING THE COUNTY MAYOR OR  
MAYOR'S DESIGNEE TO WORK WITH THE COUNTY'S  
OFFICE OF COMMUNITY ADVOCACY AND THE FLORIDA  
DEPARTMENT OF HEALTH TO PROMOTE HIV/AIDS  
PREVENTION AWARENESS IN MIAMI-DADE COUNTY

**WHEREAS**, according to the United States Department of Health and Human Services, Human Immunodeficiency Virus ("HIV") and Acquired Immunodeficiency Syndrome ("AIDS," and together with HIV, "HIV/AIDS") is transmitted through bodily fluids, including blood, semen, pre-seminal fluid, rectal fluids, vaginal fluids and breast milk; and

**WHEREAS**, according to Care Resource, a South Florida HIV/AIDS service organization, Miami-Dade County leads the nation in new AIDS cases per capita; and

**WHEREAS**, according to the Florida Department of Health, in 2013, one in 98 Miami-Dade residents was living with HIV or AIDS; and

**WHEREAS**, approximately 50,000 new HIV cases occur each year in the United States; and

**WHEREAS**, greater awareness about how HIV/AIDS is transmitted and ways to protect against transmission will help prevent individuals from becoming sick with HIV/AIDS; and

**WHEREAS**, to enhance countywide prevention awareness, Miami-Dade County should reach out to the Florida Department of Health to launch a joint campaign to promote HIV/AIDS prevention; and

WHEREAS, the County's Office of Community Advocacy has devised the slogan, "There's No Cure, but 100% Prevention," for use in promoting awareness of HIV/AIDS prevention,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor or Mayor's designee to work with the County's Office of Community Advocacy within the Office of the Chairperson of the County Commission and the Florida Department of Health to promote awareness of HIV/AIDS prevention in Miami-Dade County.

The Prime Sponsor of the foregoing resolution is Chairwoman Rebeca Sosa. It was offered by Commissioner **Sally A. Heyman**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
