RESOLUTION NO. R-1094-14

RESOLUTION APPROVING THE CITY OF MIAMI
CODESIGNATION OF SW 4TH AVENUE FROM SW 4TH
STREET TO SW 5TH STREET AS "SISTER MARGARITA
MIRANDA OTERO R.S.C.J. WAY"

WHEREAS, on September 29, 2014, the Miami City Commission adopted Resolution No. R-14-0371, which codesignated SW 4th Avenue from SW 4th Street to SW 5th Street as "Sister Margarita Miranda Otero R.S.C.J. Way", in recognition of her contributions to the City of Miami, a copy of which is attached and incorporated by reference; and

WHEREAS, Sister Margarita Miranda Otero was born in Havana, Cuba in 1911; and

WHEREAS, at the age of 21, she joined the Society of the Sacred Heart Religieuses du Sacré Coeur de Jésus ("R.S.C.J."), later becoming the principal of the Sacred Heart School in Santiago de Cuba and subsequently in El Cerro, Havana; and

WHEREAS, after Fidel Castro seized power in Cuba, Sister Margarita immigrated to Miami, Florida, where she resided and taught at the Carrollton School of the Sacred Heart in Coconut Grove; and

WHEREAS, Sister Margarita soon became concerned about children being home alone after school while their parents were still at work; and

WHEREAS, as a result, she and a group of volunteers began donating their time and talents to the Little Havana community, ultimately creating an informal after-school program that quickly expanded to classrooms within the Ada Merritt School, where English, religion, and cultural activities such as music, art and dance were taught; and

WHEREAS, in 1968, Sister Margarita formally founded Centro Mater Childcare Services, in homage to the Virgin Mary (Mater Admirabilis) patroness of the religious of the Sacred Heart; and

WHEREAS, Centro Mater Childcare Services is a nonprofit organization that strives to aid economically disadvantaged families by providing quality childcare and education services; and

WHEREAS, Centro Mater Child Care Center is located at 418 SW 4th Avenue in Miami; and

WHEREAS, SW 4th Avenue from SW 4th Street to SW 5th Street is a city street located in the City of Miami; and

WHEREAS, the City of Miami wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, this Board would like to honor the memory of Sister Margarita Miranda Otero, who recently passed away, by approving the City of Miami codesignation of SW 4th Avenue from SW 4th Street to SW 5th Street as "Sister Margarita Miranda Otero R.S.C.J. Way";

WHEREAS, this codesignation is located in County Commission District 5,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Miami codesignation of SW 4th Avenue from SW 4th Street to SW 5th Street as "Sister Margarita Miranda Otero R.S.C.J. Way".

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor of the City of Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services

Division of the Regulatory and Economic Resources Department, the City of Miami Police Department and the City of Miami Fire-Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Bruno A. Barreiro. It was offered by Commissioner **Esteban L. Bovo, Jr.**, who moved its adoption. The motion was seconded by Commissioner **Xavier L. Suarez** and upon being put to a vote, the vote was as follows:

A RESOLUTION OF THE MIAMI CITY COMMISSION CODESIGNATING SOUTHWEST 4TH AVENUE FROM SOUTHWEST 4TH STREET TO SOUTHWEST 5TH STREET, MIAMI, FLORIDA, AS "SISTER MARGARITA MIRANDA OTERO R.S.C.J. WAY"; FURTHER DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE HEREIN DESIGNATED OFFICES.

WHEREAS, Sister Margarita Miranda Otero joined the Society of the Sacred Heart Religieuses du Sacré Coeur de Jésus ("R.S.C.J.") at the age of twenty-one (21), later becoming the principal of the Sacred Heart School in Santiago de Cuba and later in El Cerro, Havana, Cuba; and

WHEREAS, Sister Margarita Miranda Otero resided and taught at The Carrollton School of the Sacred Heart in Coconut Grove, Miami, Florida; and

WHEREAS, Sister Margarita Miranda Otero and a group of volunteers were concerned about the situation where children were home alone after school while their parents worked; and

WHEREAS, Sister Margarita Miranda Otero and volunteers donated their time and talents to the Little Havana community; and

WHEREAS, Sister Margarita Miranda Otero created an informal "after-school program" that quickly expanded to classrooms within Ada Merritt School, where English, Religion, and cultural activities including music, art and dance were taught; and

WHEREAS, the after-school program was later formally named in homage to the Virgin Mary (Mater Admirabilis) patroness of the religious of the Sacred Heart Centro Mater;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as fully set forth in this section.

Section 2. Southwest 4th Avenue from Southwest 4th Street to Southwest 5th Street, Miami, Florida, is codesignated as "Sister Margarita Miranda Otero R.S.C.J. Way."

Section 3. The City Manager is directed to instruct the City Clerk to transmit a copy of this Resolution to the Departments of Police, Fire-Rescue, Solid Waste, Miami-Dade County Public Works and Waste Management and the United States Postal Service.

Section 4. This Resolution shall become effective immediately upon its adoption and signature of the Mayor. {1}
