Subject: Resolution Authorizing Implementation of a New Bus Route (Interstate 95 Dade/Broward Express Civic Center) to be Implemented on or after April 1, 2015

RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) approve a resolution for a new bus route (Interstate 95 Dade/Broward Express Civic Center) to commence service on or after April 1, 2015. Board approval subsequent to a public hearing regarding the new bus route is required per Chapter 2, Article XIX, Section 2-150 of the Miami-Dade County Code.

SCOPE

The alignment of this service spans Commissioner Barbara Jordan's District 1, Commissioner Jean Monestime's District 2, Commissioner Audrey Edmonson's District 3, and Commissioner Sally Heyman's District 4. While these funds provide support for a bus service along the Interstate 95 transportation corridor, the impact of the project benefits the riding public and is, therefore, countywide.

FISCAL IMPACT

There is no fiscal impact to the County, as the service will be funded entirely with a Transit Corridor Program Grant from the Florida Department of Transportation (FDOT) in the amount of \$2,472,000.00 annually (R-390-14).

TRACK RECORD/MONITOR

The Miami-Dade Transit (MDT) employee responsible for management and oversight of the proposed new service is Gerald Bryan, Chief, Service Planning and Scheduling.

BACKGROUND


The State Transit Corridor Program is authorized by Chapter 341 of the Florida Statutes. The program provides funding to relieve traffic congestion and improve road capacity within identified transportation corridors by increasing the people-carrying capacity of the systems through the use and facilitated movement of high-occupancy conveyances. Transit Corridor Program funds are intended to alleviate congestion in designated transportation corridors such as Interstate 95 (I-95) and are eligible to receive up to 100 percent of State funding.

In August 2007, the Miami-Urban Partnership comprised of FDOT, MDT, Miami-Dade Metropolitan Planning Organization, the Broward Metropolitan Planning Organization, Broward County Transit, the Miami-Dade Expressway Authority and the Florida Turnpike Enterprise entered into an Urban Partnership Agreement to convert 21 miles of two (2) high-occupancy vehicle (HOV) lanes (one in each direction) along I-95, from I-395 in Miami to I-595 in Fort Lauderdale into variably-priced high-occupancy toll (HOT) lanes. A major component of the project included implementing new express bus service within the HOT lanes between Broward and Miami-Dade Counties.

On January 25, 2010, MDT began Phase 1 of the I-95 Dade/Broward Express Route service. MDT will implement the second phase of the I-95 Dade/Broward Express service with operation along the same alignment as Phase I, but with direct service to the Civic Center in Miami (NW 15th Street and 12th Avenue).


Specifically, the new service will operate in the I-95 express lanes and serve the Broward Boulevard Tri-Rail Station Park-and-Ride lot, the Sheridan Street Tri-Rail Station Park-and Ride Lot, and the Civic Center area in Miami-Dade County (Attachment A). The route will operate only on weekdays, every 30 minutes between the hours of approximately 5:30 am - 9:30 am (AM peak) and 3:30 pm - 8:00 pm (PM peak).

The proposed new service requires a public hearing prior to implementation (Attachment B). In accordance with the Collective Bargaining Agreement (CBA), officers of the Transport Workers' Union Local 291 (TWU) have been provided information on the proposed new service for their review at departmental line-up planning committee meetings. MDT staff will continue to work closely with TWU throughout the scheduling process to ensure implementation of the new service.



RESOLUTION AUTHORIZING MIAMI-DADE TRANSIT TO IMPLEMENT NEW INTERSTATE 95 DADE/BROWARD EXPRESS BUS SERVICE FROM BROWARD BOULEVARD AND SHERIDAN STREET TRI-RAIL STATION PARK AND RIDE LOTS TO THE CIVIC CENTER ON OR AFTER APRIL 1, 2015

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Miami-Dade Transit has analyzed the proposed route and determined that the addition of this new service will enhance the regional transit connections of the transit system; and

WHEREAS, a Public Hearing was held at the Transportation and Aviation Committee,
