Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners (Board) for approval. This plat is bounded on the north by SW 272 Street, on the east by SW 164 Court, on the south approximately 1,220 feet north of SW 276 Street, and on the west by SW 165 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management, and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located in Commission District 8, which is represented by Commissioner Daniella Levine Cava.

Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this plat; all improvements are in place.

Track Record/Monitor

The Development Services Division of RER administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

MARY'S MANOR (T-23213)

- Located in Section 32, Township 56 South, Range 39 East
- Zoning: EU-M
- Proposed Usage: Single family residences
- Number of parcels: 2
- This plat meets concurrency

Plat Restrictions

- That the Street, Avenue and Court, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.

- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

Developer's Obligation

- None, all improvements are in place.

RESOLUTION NO. R-292-15

RESOLUTION APPROVING THE PLAT OF MARY'S MANOR, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 32, TOWNSHIP 56 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 272 STREET, ON THE EAST BY SW 164 COURT, ON THE SOUTH APPROXIMATELY 1,220 FEET NORTH OF SW 276 STREET, AND ON THE WEST BY SW 165 AVENUE)

WHEREAS, Mary Schwebach, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as MARY'S MANOR, the same being a replat of Lot 1, Block 1 of "Melody Manor", according to the plat thereof, as recorded in Plat Book 63, at Page 18, of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 32, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.


