

RESOLUTION APPROVING THE CITY OF DORAL  
CODESIGNATION OF THAT PORTION OF NW 53RD  
STREET FROM NW 87TH AVENUE TO NW 79TH AVENUE  
AS "MAIN STREET"

**WHEREAS**, on June 9, 2010, the Mayor and City Council of the City of Doral adopted Resolution No. 10-100, which codesignated that portion of NW 53rd Street from NW 87th Avenue to NW 79th Avenue as "Main Street", a copy of which is attached hereto and incorporated by reference; and

**WHEREAS**, in recognition of the City of Doral's development efforts in this area, this Board would like to approve the City of Doral codesignation of that portion of NW 53rd Street from NW 87th Avenue to NW 79th Avenue as "Main Street"; and

**WHEREAS**, that portion of NW 53rd Street from NW 87th Avenue to NW 79th Avenue is a city street located in the City of Doral; and

**WHEREAS**, the City of Doral wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

**WHEREAS**, this codesignation is located in County Commission District 12,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Approves the City of Doral codesignation of that portion of NW 53rd Street from NW 87th Avenue to NW 79th Avenue as "Main Street".

**Section 2.** Directs the Clerk of the Board to send a certified copy of this Resolution to the Mayor and Council Members of the City of Doral, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the

Development Services Division of the Regulatory and Economic Resources Department, the City of Doral Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner **Xavier L. Suarez**, who moved its adoption. The motion was seconded by Commissioner **Daniella Levine Cava** and upon being put to a vote, the vote was as follows:




