RESOLUTION NO. R-784-15

RESOLUTION URGING THE FLORIDA LEGISLATURE TO PURSUE FEDERAL ASSISTANCE TO SUPPORT FARMERS AFFECTED BY THE RECENT FRUIT FLY INFESTATION IN MIAMI-DADE COUNTY; FURTHER URGING THE LEGISLATURE TO DEVELOP A STATE PROGRAM TO ASSIST FARMERS IN OVERCOMING SIMILAR AGRICULTURAL EMERGENCIES

WHEREAS, on September 15, 2015, Florida Commissioner of Agriculture Adam H. Putnam declared a state of agricultural emergency due to the Oriental Fruit Fly infestation in Miami-Dade County; and

WHEREAS, the Oriental Fruit Fly is considered one of the most invasive and economically costly pests because it attacks more than 430 different fruits, vegetables, and nuts; and

WHEREAS, since the first detection of the Oriental Fruit Fly on August 26, 2015, over 150 flies have been detected in Miami-Dade County; and

WHEREAS, the Oriental Fruit Fly threatens Florida's \$123 billion agriculture industry and, locally, Miami-Dade County's \$1.6 billion industry and 11,000 jobs; and

WHEREAS, Miami-Dade County is the state's leader in the production of tropical vegetables, fruits, and ornamental nurseries; and

WHEREAS, the Florida Department of Agriculture and Consumer Services ("FDACS") has quarantined an 85-square mile area around the core areas where detections have been made in order to prevent the spread of the fly; and

WHEREAS, the FDACS has also treated several areas with pesticides, removed fruit from host trees, and set up fly detection systems throughout Miami-Dade County to monitor the infestation; and

WHEREAS, the Oriental Fruit Fly is a threat to agricultural production in the United States more generally, with recent infestations occurring in Hawaii and California; and

WHEREAS, assistance from the federal government in any capacity to alleviate the economic damage stemming from an Oriental Fruit Fly infestation will greatly assist both the FDACS and Florida farmers in restoring the health of valued agricultural crops; and

WHEREAS, farmers in Florida would benefit from a state operated program designed to provide assistance to them, monetary or otherwise, in similar or future instances of agricultural emergency; and

WHEREAS, this Board has always supported measures taken to protect economic interests and development in Miami-Dade County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to pursue federal assistance to support farmers affected by the recent fruit fly infestation in Miami-Dade County.

Section 2. Urges the Florida Legislature to develop a state program to assist farmers in overcoming similar agricultural emergencies in the future.


Section 3. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, Senate President, House Speaker, Florida Department of Agriculture and Consumer Services Commissioner Adam H. Putnam, and the Chair and Members of the Miami-Dade State Legislative Delegation.

Section 4. Directs the County's state lobbyists to advocate for the legislation set forth in Sections 1 and 2 above, and authorizes and directs the Office of Intergovernmental Affairs to include this item in the 2016 State Legislative Package when it is presented to the Board.

The Prime Sponsor of the foregoing resolution is Commissioner Dennis C. Moss. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Esteban L. Bovo, Jr.** and upon being put to a vote, the vote was as follows:
