

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE MAY 30, 2015 "TURN UP FOR EDUCATION" EVENT SPONSORED BY THE UNITED TEACHERS OF DADE IN AN AMOUNT NOT TO EXCEED \$910.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 3 FY 2014-15 IN-KIND RESERVE FUND

WHEREAS, the United Teachers of Dade has requested in-kind services from the Parks, Recreation and Open Spaces Department for the May 30, 2015 "Turn Up for Education" event in an amount not to exceed \$910.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Turn Up for Education" event is to, among other things, promote education, community peace, and wellness in the community; and

WHEREAS, the "Turn Up for Education" event is a district event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$910.00 of the in-kind services shall be funded from the balance of the District 3 FY 2014-15 In-Kind Reserve funds,
