

SUBJECT: Resolution directing the County Mayor to prepare and distribute a written report to all Board members setting forth all Major Departmental Initiatives; and defining Major Departmental Initiative for the purpose of this Resolution

Resolution No. R-516-16

This item was amended at the May 10, 2016 Strategic Planning & Government Operations Committee. This amendment changes the County Mayor's or designee's reporting requirement from weekly to quarterly; defines a "Major Departmental Initiative" as one that creates significant regional impacts or otherwise significantly impacts a regional asset, instead of giving the County Mayor or designee discretion to determine what constitutes a "Major Departmental Initiative;" and directs the County Mayor or designee to report Commission District-specific impacts to the District Commissioner, instead of to the entire Board.

The accompanying resolution was prepared and placed on the agenda at the request of Prime Sponsor Senator Javier D. Souto.

RESOLUTION NO. R-516-16

RESOLUTION DIRECTING THE COUNTY MAYOR OR DESIGNEE TO PREPARE AND DISTRIBUTE A WRITTEN REPORT TO ALL BOARD MEMBERS SETTING FORTH ALL MAJOR DEPARTMENTAL INITIATIVES; AND DEFINING MAJOR DEPARTMENTAL INITIATIVE FOR THE PURPOSE OF THIS RESOLUTION

WHEREAS, Miami-Dade County's Charter provides that the "Board of County Commissioners shall be the . . . governing body of the County" and further empowers the Board to make inquiries "of any department or office of the county"; and

WHEREAS, consistent with those powers and duties, and in order to better anticipate, study and, as necessary and appropriate, provide guidance and recommendations to the County Mayor or designee, this Board desires to receive a ~~[[weekly]]~~¹ >>quarterly<< summary, in writing, of major departmental initiatives ("Major Departmental Initiatives"), as defined in this resolution,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The County Mayor or designee is directed to prepare and distribute to all Board members, on a ~~[[weekly]]~~ >>quarterly<< basis, a written report setting forth all Major Departmental Initiatives for each County department. If, in the estimation of the County Mayor or designee, there are no new Major Departmental Initiatives to report to Board members, the County Mayor or designee shall so state in the written report. >>If, in the judgment of the

County Mayor or designee an initiative does not qualify as a "Major Departmental Initiative," as defined in Section 2, because the initiative only impacts a particular Commission District, then the County Mayor or designee shall inform the Commissioner of the affected Commission District as the impact arises, either orally or in writing.<<

Section 2. For the purpose of this resolution, a Major Departmental Initiative is any undertaking by a County department that [~~in the judgment of the County Mayor or designee, significantly impacts how that particular County department will interact with the public, or which will cause an increase or reduction of services to be provided by that County department to the public]] >>creates significant regional impacts or otherwise significantly impacts a regional asset<<. The County Mayor or designee shall treat the imposition of any new fees or the reduction of any existing fees on County residents as a Major Departmental Initiative.~~

The Prime Sponsor of the foregoing resolution is Senator Javier D. Souto. It was offered by Commissioner **Esteban L. Bovo, Jr.** , who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
