

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE APRIL 16, 2016 "VIKING FEST" SPONSORED BY ARVIDA MIDDLE SCHOOL IN AN AMOUNT NOT TO EXCEED \$1,100.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 8 FY 2015-16 IN-KIND RESERVE FUND

WHEREAS, Arvida Middle School has requested in-kind services from the Parks, Recreation and Open Spaces Department for the April 16, 2016 "Viking Fest" in an amount not to exceed \$1,100.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Viking Fest", which is a family-friendly event, is to raise funds to benefit the music and art programs at the school; and

WHEREAS, the "Viking Fest" event is a district event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$1,100.00 of the in-kind services shall be funded from the balance of the District 8 FY 2015-16 In-Kind Reserve funds,






