SUBJECT: Resolution Authorizing Execution of Memoranda of Understanding between the United States Attorney for the District of Columbia, the Metropolitan Police Department of Washington, D.C., and Miami-Dade County

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached resolution authorizing the County Mayor or County Mayor's designee to execute the Memoranda of Understanding (MOU) between the United States Attorney for the District of Columbia, the Metropolitan Police Department of Washington, D.C., and Miami-Dade County, through the Miami-Dade Police Department (MDPD). The purpose of the MOU is to assist the Metropolitan Police Department, the primary law enforcement agency responsible for ensuring the safety of the participants and of the public during the 2017 Presidential Inauguration and the related events. The MOU will be effective from January 15, 2017, through January 21, 2017.

Scope

The MOU provides law enforcement assistance to the Metropolitan Police Department by having MDPD sworn personnel serve as members of the Presidential Inauguration Task Force.

Delegation of Authority

Upon approval by the Board, the County Mayor or County Mayor's designee is authorized to execute the MOU between the United States Attorney for the District of Columbia, the Metropolitan Police Department of Washington, D.C., and Miami-Dade County, and to execute any necessary modifications relating to this special assignment.

Fiscal Impact/Funding Source

The Metropolitan Police Department will pay the costs associated with this MOU for the MDPD sworn personnel assigned, including salary and fringes, air travel, lodging, ground travel, and per diem; thus, there is no fiscal impact to the County.


Track Record/Monitor



RESOLUTION APPROVING THE TERMS AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE ACTION TO EXECUTE THE MEMORANDUM OF UNDERSTANDING BETWEEN THE UNITED STATES ATTORNEY FOR THE DISTRICT OF COLUMBIA, THE METROPOLITAN POLICE DEPARTMENT OF WASHINGTON, D.C., AND MIAMI-DADE COUNTY THROUGH THE MIAMI-DADE POLICE DEPARTMENT; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE ACTION TO EXECUTE MODIFICATIONS AS NECESSARY RELATING TO THIS SPECIAL ASSIGNMENT AND TO EXERCISE ANY AND ALL PROVISIONS CONTAINED THEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board approves the terms and authorizes the execution by the County Mayor or the County Mayor's designee of the Memorandum of Understanding between the United States Attorney for the District of Columbia, the Metropolitan Police Department of Washington, D.C. and Miami-Dade County, through the Miami-Dade Police Department, which is not attached hereto for security reasons, and authorizes the County Mayor or County Mayor's designee to execute modifications as necessary relating to this special assignment, and to exercise any and all provisions contained in the Memorandum of Understanding, for and on behalf of Miami-Dade County.
