As discussed, LaserNet will provide two (2) 8W RGB ScannerPro projectors to be located on each side of the grassy area. The bright, full-color lasers will create aerial patterns, (tunnels, waves, beams and more) over the heads of the audience. LaserNet will provide operator who will install and strike the systems. In addition, LaserNet will supply two smoke machines and generators for the night.



Option 2: Four (4) 6W lasers to be positioned in each corner of the grassy area and surround the audience. The lasers will create the same full-color laser patterns, but the audience will be surrounded by laser beams. Includes two smoke machines and generators.



**LOW LEVEL FOG** – Watch the fog roll off the stage, or, cover the dance floor, with our CO2 based fog machines. The CO2 super-cools the fog to keep it at a low level for dramatic effects.


**LASER REVEAL** – Using our high powered YAG laser imbedded in the stage, we can shoot the beams up to an overhead 12' wide mirror which reflects the beams back down to the stage. 



As per our conversation, I have attached several different special effects we can supply. All the items are top notch and guaranteed to jump any event into high gear.




**VIP CO2 FOG Intro.** Six of our CO2 fog jets can be positioned on stage to surround the entrance of the VIP. Upon a specific music cue, we will blast a 20' high wall of fog to shield the entrance to the stage of the CEO. As the 20 second blast fills the stage with fog, the CEO walks to the center of the fog and waits for the fog to clear, thus magically

revealing the CEO standing on stage from out of nowhere. **\$2,800**




**CONFETTI STORM** – 4 confetti blowers positioned on the floor around the audience. At a specific cue, the CO2 powered blowers will shoot out multi colored bits of confetti. The confetti can be many different shapes, colors, or, material, such as, mylar. The blowing confetti will fill the entire room in seconds and envelope the audience in a stunning storm of flying color. Can be bio-degradable for outdoor shows, does not include clean-up. **\$5,750**

**Name/Logo in PYRO.** We can unveil 4' tall x12' wide sign (or bigger), either hanging, or, standing on stage, of a flaming logo. The logo will contain a line of pyrotechnic flares that will light up on command. The flaming logo will typically last 20 – 30 seconds and makes a really big impact. **\$6,500**



**LASER BEAMS** - Our large 20W green "Beam Raider" laser projectors for shooting beams and aerial patterns over the audience. This unit can be located inside or out to create extremely bright patterns over the audience. We will place target bounce mirrors to create 3-dimensional beam structures changing to the beat of the music. A smoke machine will also be used to enhance the appearance of the laser show. **\$7,500**



**FULL COLOR LASER** – Utilizing our 8Watt White light "ScannerPro" laser system we will shoot beams and aerials in full color. In addition, we will bring our 12' wide roll-down, see-thru scrim, to show the event logos. Because laser beam image will past through our see-thru scrim, the images will appear to float in mid air over the stage. Logos and text
