

RESOLUTION NO. R-941-16

RESOLUTION SUPPORTING THE 2016 WINGS OVER
HOMESTEAD AIR SHOW

WHEREAS, on November 5 and 6, 2016, the United States Air Force Thunderbirds F-16 Demonstration Team will be flying in the skies over Homestead Air Reserve Base during the 2016 Wings Over Homestead Air Show; and

WHEREAS, this year's event theme is "Spirit of Flight, Celebrating Superior Air Power"; and

WHEREAS, the Wings Over Homestead Air Show returns in 2016 after a four year absence; and

WHEREAS, in 2012, the Wings Over Homestead Air Show was attended by almost 300,000 people making it one of the best attended air shows in the country; and

WHEREAS, the Thunderbirds Squadron is an air combat command unit composed of eight pilots, four support officers, four civilians and more than 100 enlisted personnel performing in almost 30 job specialties; and

WHEREAS, flying the Lockheed Martin F-16 Fighting Falcon, the red, white, and blue jets of the Thunderbirds Squadron have been witnessed by more than 280 million people in all 50 states and in 57 foreign countries in more than 3,500 aerial demonstrations; and

WHEREAS, also announced for the 2016 Homestead Air Show is the United States Army parachute team, the Golden Knights; and

WHEREAS, the Golden Knights, with their spectacular live parachute demonstrations, have performed more than 16,000 shows in all 50 states and in 48 countries, with more than 20,000 attendees per show; and

WHEREAS, Homestead Air Reserve Base is the winter home of the Golden Knights; and

WHEREAS, besides the Thunderbirds Squadron and the Golden Knights, many other warbirds, classic and vintage aircraft, along with military vehicles and aviation-related items will be on display for up-close viewing by the public at the 2016 Wings Over Homestead Air Show; and

WHEREAS, the 482nd Fighter Wing will host the 2016 Wings Over Homestead Air Show; and

WHEREAS, the 482nd Fighter Wing maintains and operates Homestead Air Reserve Base and is a fully combat-ready unit capable of providing F-16C multi-purpose fighter aircraft, mission-ready pilots and support personnel on short-notice for worldwide deployment; and

WHEREAS, the Board would like to express its support for the 2016 Wings Over Homestead Air Show, and also would like to express its continuing support for members of the United States Armed Forces and their families within Miami-Dade County, across the United States and stationed around the world,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board supports the Wings Over Homestead Air Show that will take place on November 5 and 6, 2016 at Homestead Air Reserve Base.

The Co-Prime Sponsors of the foregoing resolution are Commissioner Jose "Pepe" Diaz and Commissioner Dennis C. Moss. It was offered by Commissioner **Sally A. Heyman**, who moved its adoption. The motion was seconded by Commissioner **José "Pepe" Diaz** and upon being put to a vote, the vote was as follows:
