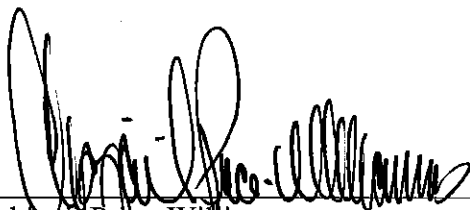

RESOLUTION NO. R-1046-16

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO DESIGN SIGNAGE WARNINGS CONCERNING POSSIBLE PRESENCE OF DANGEROUS WILDLIFE AT OR NEAR COUNTY PARKS; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PREPARE AND SUBMIT A WRITTEN REPORT TO THE BOARD WITHIN 90 DAYS CONCERNING THE DESIGN AND INSTALLATION OF SIGNAGE; AND DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO INSTALL SIGNAGE WITHIN LEGALLY AVAILABLE FUNDING IN THE FY 2015-16 AND 2016-17 BUDGETS

WHEREAS, Miami-Dade County, through its Parks, Recreation and Open Spaces Department owns and operates nearly 300 public parks, many of which include bodies of water, such as lakes and canals, within their boundaries; and

WHEREAS, dangerous wildlife, including most notably the American alligator, is endemic to the County and may exist in bodies of water within County parks, even though the County has not introduced them into those bodies of water and has not otherwise harbored or demonstrated an intent to possess that wildlife within its parks; and

WHEREAS, County parks may attract visitors demonstrating varying levels of familiarity with the dangers inherent to coexisting with that dangerous wildlife; and

WHEREAS, given those varying levels of familiarity amongst possible visitors to County parks, to the extent feasible and contextually appropriate, and even in instances in which the County lacks specific awareness of the presence of dangerous wildlife in a particular body of water within a park, this Board desires to install signage as determined by the County Mayor or County Mayor's designee, advising the visiting public of the possibility that bodies of water within the park may contain dangerous wildlife,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The County Mayor or County Mayor's designee is directed to design signage warning individuals visiting County parks of the possible presence of alligators within bodies of water located in or near those parks >>or of any other dangerous wildlife (e.g., bears, foxes, snakes, or panthers) located in parks<<¹. The County Mayor or County Mayor's designee is further directed to prepare a report identifying the specific County parks, in order of priority, for which signage is proposed. The report prepared by the County Mayor or County Mayor's designee shall additionally identify the fiscal impact associated with the installation of the proposed signage. The County Mayor or County Mayor's designee shall provide the report to this Board within 90 days of the effective date of this resolution and shall place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.

Section 2. To the extent sufficient legally available funds exist within the FY 2015-16 budget for the installation of the signs proposed pursuant to Section 1, or to the extent sufficient funds are available in the FY 2016-17 budget when adopted, then the County Mayor or County Mayor's designee is directed to utilize that funding for the design and installation of such signage in the order of priority identified in the report prepared pursuant to Section 1.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz, and the Co-Sponsors are Commissioner Daniella Levine Cava and Senator Javier D. Souto. It was offered by Commissioner **Esteban L. Bovo, Jr.**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:

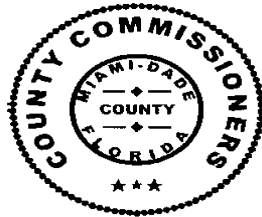
