ORDINANCE NO. 17-59

ORDINANCE **APPROVING** AND ADOPTING THE COUNTYWIDE GENERAL FUND BUDGET FOR MIAMI-DADE COUNTY, FLORIDA, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018; PROVIDING A SHORT TITLE; INCORPORATING THE FISCAL PROPOSED BUDGET AS 2017-18 AMENDED; APPROPRIATING ALL BUDGETED REVENUES EXPENDITURES: AUTHORIZING THE INVESTMENT OF COUNTY FUNDS IN THE TIME WARRANTS OF MIAMI-DADE COUNTY: AUTHORIZING THE TRANSFER OF FUNDS AS CASH ADVANCES PENDING RECEIPT OF TAXES OR OTHER REVENUES: AUTHORIZING DEPOSIT OF INTEREST EARNED TO THE GENERAL FUND; RATIFYING AND APPROVING IMPLEMENTING ORDERS AND OTHER ACTIONS OF THE BOARD WHICH SET FEES, RATES, AND CHARGES; AUTHORIZING FEES, RATES, AND CHARGES CONSISTENT WITH APPROPRIATIONS, AND PROVIDING FOR THEIR AMENDMENT; AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXECUTE CERTAIN FUNDING AGREEMENTS; WAIVING FOR FISCAL YEAR 2017-18 PROVISIONS OF SECTIONS 2-1799(E) AND 2-1799(F)1 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA ("CODE"), RELATED TO THE DISPOSITION OF UNEXPENDED MAYORAL OFFICE BUDGET FUNDS AND UNALLOCATED CARRYOVER FUNDING IN THE COUNTYWIDE GENERAL FUND BUDGET: AMENDING, WAIVING OR RESCINDING, IF NECESSARY, VARIOUS SECTIONS OF THE CODE APPLICABLE, IMPLEMENTING ORDERS AND OTHER LEGISLATIVE ENACTMENTS TO CONFORM SUCH ENACTMENTS TO THE FISCAL YEAR 2017-ADOPTED BUDGET; SUPERSEDING CONFLICTING PROVISIONS OF PRIOR LEGISLATIVE ENACTMENTS: AND PROVIDING SEVERABILITY, EXCLUSION FROM THE CODE AND AN EFFECTIVE DATE

BE IT ORDAINED, BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMIDADE COUNTY, FLORIDA:

Section 1. This ordinance shall be known and may be cited as the "Fiscal Year 2017-18 Miami-Dade County Countywide Budget Ordinance."

Section 2. Pursuant to Section 5.03(B) of the Home Rule Charter, the County Mayor has recommended a proposed budget for Miami-Dade County, Florida, for the fiscal year commencing October 1, 2017. Said proposed budget document as submitted to the Board of County Commissioners ("Board") is incorporated herein by reference and is amended to include: (a) all of the applicable changes contained in this ordinance; (b) the changes contained in the September 7, 2017 memorandum entitled "Information for First Budget Hearing - FY 2017-18 Proposed Budget"; and (c) the changes contained in the September 28, 2017 memorandum entitled "Information for Second Budget Hearing - FY 2017-18 Proposed Budget" as further amended by changes read into the record by the First Assistant County Attorney correcting scriveners errors on pages 31 and 33 of Implementing Order 4-68 (Attachment B of the Information for Second Budget Hearing memorandum previously referenced above) correcting the "Residential Container Service per household" to read \$358.00 and the "Multi-family Collection per living unit" to read \$186.00; and (d) the amendments adopted by motion to: i) with respect to transit, maintain the status quo regarding Sunday service for six holidays, ii) allocate proceeds resulting from settlements with Uber Technologies, Inc. and Lyft, Inc., if such settlements are reached, as follows: \$500,000.00 to the Miami Children's Museum for the replacement of the heating, ventilation and air conditioning (HVAC) system, \$500,000.00 to the African American (Black History) Museum for plans and studies for the construction of a new museum, and the remainder of any such proceeds to the Affordable Housing Trust Fund, iii) fund from the Parks, Recreation and Open Spaces Department budgeted allocation for part-time employees ten (10) new full-time Park Manager 1 positions to be filled by waiving the competitive recruitment process for such positions, iv) provide a status report on Little Havana Activities and Nutrition Center within 30 days of the second budget hearing, and v) establish as County policy that, subject to annual appropriation, the amounts referenced in the extraordinary adjustments in Countywide General Fund support included in the 40-year PTP pro forma represented by the information for fiscal years 2019 through 2023 as referenced on page 109 of Volume 1

of the FY 2017-18 Proposed Budget and Multi-Year Plan be allocated to implementation of the Smart Plan rapid transit corridors and directing the Mayor or designee to incorporate this policy into upcoming budgets. These changes are incorporated into the version attached hereto.

The Countywide General Fund budget, including the five-year Section 3. financial plan contained therein, as amended as set forth in this ordinance, is hereby approved and adopted, and the budgeted revenues and expenditures therein are hereby appropriated. Department expenditure allocations established by the County Mayor as revised and summarized in the attached budget are adopted as limitations of all expenditures, except as hereinafter provided, and appropriations have been hereby provided for outstanding indebtedness for the payment of vouchers that have been incurred in the current or prior year, but are not expected to be paid until the commencement of the new fiscal year. Receipts from sources not anticipated in the attached budget may be appropriated and expended by ordinance duly enacted by the Board in accordance with Section 129.06(2)(d), Florida Statutes, and Section 1.02(A) of the Miami-Dade County Home Rule Charter. Adjustments within the same fund to departmental appropriations made in the attached budget may be approved from time to time by motion duly adopted by the Board in accordance with Section 129.06(2)(a), Florida Statutes, and Ordinance No. 07-45, as amended. The Director of the Office of Management and Budget is authorized to approve adjustments to expenditure code allocations within the limit of the departmental or other appropriations made in the attached budget. All adjustments made in accordance with this ordinance are approved and ratified.

Section 4. Pursuant to the authority of Chapter 8015, Special Acts of Florida, 1919, which authorizes the Board to borrow money and to issue time warrants, and pursuant to the authority of Section 129.02(5), Florida Statutes, which permits funds of the County to be invested in securities of the federal government and of the local governments in Florida,

or both, the Finance Director is hereby authorized to invest these monies in the time warrants of Miami-Dade County, Florida.

Section 5. As provided in Section 5.03(C) of the Home Rule Charter, the Board hereby authorizes the transfer of any portion of the earnings or balance of the several funds, other than sinking funds for obligations not yet retired, to the general funds of the County, provided that such transfer be deemed a cash advance to meet operating and other expenses approved by the Board, and that all such advances shall be reimbursed before the end of the fiscal year upon receipt of adequate tax or other appropriate revenues. Provided, however, that this section in no way limits or restricts the power of the Board to transfer any unencumbered appropriation balance, or any portion thereof, from one department, fund or agency to another as provided by law pursuant to Section 5.03(C) of the Home Rule Charter.

Section 6. The Finance Director, pursuant to Section 5.03(C) of the Home Rule Charter, is hereby authorized to deposit to the accounts of the General Fund any interest on deposits earned or accrued to the benefit of any trust funds, revolving accounts, working capital reserves or other funds held in trust by Miami-Dade County, unless specifically prohibited from doing so by trust or other agreements.

Section 7. The provisions of Section 2-1799(e) of the Code of Miami-Dade County, Florida, requiring that unexpended funds in the Mayoral office budget be designated as reserves at the end of the fiscal year in which the funds were unexpended and added to the Mayoral office budget in the following fiscal year, are waived to permit the use of funds unexpended as of September 30, 2017 from the Mayoral office budget as Fiscal Year 2016-17 General Fund carryover for appropriation to the Fiscal Year 2017-18 Adopted Budget as approved by the Board. The provisions of Section 2-1799(f)1 of the Code of Miami-Dade County, Florida, requiring that 50 percent of the unallocated carryover funds in the Countywide general fund budget be allocated to the Capital Outlay Reserve fund in the fiscal year following the fiscal year the funds were identified to support County services, are

waived for Fiscal Year 2017-18 to permit the use of carryover funds in the Countywide general fund budget that remain unallocated as of September 30, 2017 for appropriation to the Fiscal Year 2017-18 Adopted Budget as approved by the Board.

Section 8. All Implementing Orders, as amended hereby, other actions of the Board setting fees, rates, and charges, and fees, rates, and charges consistent with appropriations adopted herein, are hereby ratified, confirmed and approved, and may be amended by resolution adopted by the Board during the fiscal year.

Section 9. The Mayor or the Mayor's designee is hereby authorized to negotiate and execute agreements for funding allocations for community-based organizations and Mom and Pop Program participants approved in this ordinance as a result of a request for proposals or other formal selection process or other allocations, including individual allocations, approved by the Board in the form approved by the County Attorney.

Section 10. Notwithstanding any other provision of the Code of Miami-Dade County, Florida, or any resolution or Implementing Order to the contrary, non-profit entities awarded grants of County monies from Elected Officials Discretionary Reserve, County Services Reserve, Commission office funds or Mom and Pop Program funds shall not be required to complete affidavits of compliance with the various policies or requirements applicable to entities contracting or transacting business with the County.

Section 11. Unless otherwise prohibited by law, this ordinance shall supersede all enactments of this Board including, but not limited to, ordinances, resolutions, implementing orders, regulations, rules, and provisions of the Code of Miami-Dade County, Florida in conflict herewith.

Section 12. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder of this ordinance shall not be affected by such invalidity.

Section 13. The provisions of this ordinance shall become effective ten (10) days after the date of enactment unless vetoed by the Mayor, and if vetoed, shall become

effective only upon an override by this Board. In the event all or any particular component of this ordinance are vetoed, the remaining components, if any, shall become effective ten (10) days after the date of enactment and the components vetoed shall become effective only upon override by this Board.

Section 14. It is the intention of the Board and it is hereby ordained that the provisions of this ordinance shall be excluded from the Code of Miami-Dade County, Florida.

Information for First Budget Hearing FY 2017-18 Proposed Budget

This information has been prepared to accompany the FY 2017-18 Budget Ordinances for your consideration at the first budget hearing on September 7, 2017. This document details all adjustments identified since the submittal of the FY 2017-18 Proposed Budget (Proposed Budget) on July 11, 2017.

The attached ordinances have been adjusted for technical changes, corrections of scriveners' errors, corrections of appropriation posting errors, and current estimates of grants. Cash carryover for proprietary funds has been adjusted where appropriate. Amendments to or waiver of various code requirements and/or resolutions are recommended, including waiver of Section 2-1799 (e) to allow unexpended funds from the budget of the Office of the Mayor to revert to the General Fund carryover, Section 2-1799(f)1 related to the disposition of unallocated carryover funding in the Countywide and Unincorporated Municipal Service Area (UMSA) budgets, and Section 29-7 (G) relating to the use of Documentary Stamp Surtax, and amendment to Section 8-12(c) of the Code related to the building permit fee when work begins prior to obtaining a permit and Section 24-34 related to the utility service fee payable to the County. The recommended operating budget adjustments detailed below reduces the total operating budget by \$847,000. Further refinements to the budget and additional adjustments, if any, will be incorporated as part of the information that will be provided to the Board for the second budget hearing on September 19, 2017.

OPERATING BUDGET

Animal Services

Subsequent to the release of the Proposed Budget, the Animal Services Department (ASD) was awarded a \$150,000 American Society for the Prevention of Cruelty to Animals (ASPCA) grant to fund and enhance ASD's Pet Retention Program. Funds will be utilized to provide veterinary care, through private veterinary clinics, for pets that otherwise would be surrendered.

Miami-Dade Police Department (MDPD)

Subsequent to the release of the Proposed Budget, the Miami-Dade Police Department revised the overall funding for contracted entities resulting in a reduction of \$56,000. These reductions are reflected in the appropriation schedules for the respective contracted entities as follows: Town of Miami Lakes Local Police Patrol (\$5,000), Village of Palmetto Bay Local Police Patrol (\$8,000), Town of Cutler Bay Local Police Patrol (\$3,000), Miami-Dade Aviation Department Police Services (\$27,000), and the Port of Miami Police Services (\$13,000).

Seaport

The Department will increase membership expenditures by \$25,000 and reduce sponsorships and marketing expenditures by \$70,000, reducing the non-operating expenditures to \$540,000 from \$495,000.

Solid Waste Management

The FY 2017-18 Proposed Budget assumed a net reduction to the Contract Disposal Rate of 7.6 percent, based on a 10 percent reduction, partially offset by an estimated Consumer Price Index (CPI) increase of 2.4 percent. The actual CPI for the period was 1.5 percent making the net reduction 8.5 percent. This variance requires an adjustment in disposal revenues of \$931,000 and recycling revenues of \$10,000. Collection Operations will save in disposal expense (\$453,000) and Disposal Operations will reduce reserves by \$488,000.

RECOMMENDED FEE ADJUSTMENTS

The Self-Supporting Budget Ordinance (Agenda Item I) includes the proposed fee changes included in the Proposed Budget. Fee adjustments include charges for Animal Services (various fees), Aviation (rental and other charges), Corrections and Rehabilitation (inmate service fees), Cultural Affairs (facility rental and other various fees), Library (various fees), Medical Examiner (various fees), Seaport (contractual adjustments), Solid Waste Management (commercial disposal fees by the CPI, per ordinance), Parks, Recreation and Open Spaces (various fees), Regulatory and Economic Resources (various fees), Transportation and Public Works (various fees), and Water and Sewer (various fees). Detailed schedules were provided to the Board for review at the August 30, 2017 meeting of the Government Operations Committee. These fee schedules have all been included as reflected in the revenues of the Proposed Budget.

The Board of County Commissioners established fees for the Florida Department of Health (DOH) in Miami-Dade County, through Resolution R-1411-08, as authorized under Florida Statute 154.06. Due to increases in population since 2010, new construction, and emerging communicable diseases such as Zika, the demand for services and the cost of providing public health services in the County has increased. Therefore, DOH is requesting an increase to the DOH fee schedule. The fee increases would allow the organization to build capacity to meet the increased demand for services and augment the Health Department's ability to address future community needs for public health services. This fee schedule has also been included in Agenda Item I.

PROMOTIONAL FUNDING AND CULTURAL PROGRAMS

Attachments A and B are the reports on Airport and Seaport promotional funds as required by Administrative Order 7-32. The Seaport Department is revising the promotional fund recommended allocations by adding an allocation to the African Trade Director's Summit (\$25,000), the International Longshoremen's Association Conference (\$25,000) and the Beacon Council Business Initiatives (\$25,000), increase the Cargo and Cruise Marketing Program by \$20,000, and reduce the allocation to the Greater Miami Convention and Visitor's Bureau by \$25,000 and Cruise Lines International Association by \$25,000. The total promotional fund allocation in the Proposed Budget will be \$837,600. Attachment C reflects cultural programs monitored by Department of Cultural Affairs.

POSITION ADJUSTMENTS

In some instances, the above recommendations and correction of errors will adjust the number of positions in the FY 2017-18 Proposed Budget. These adjustments and correction of errors increase the total number of recommended full-time equivalent positions by 13 for a total of 27,176. Revisions to the tables of organization are attached (Attachment D).

PAY PLAN

Attached to Agenda Item I is the Pay Plan which contains the rates of pay for all non-bargaining unit and bargaining unit employees. The Pay Plan includes the addition of new classifications, the abolition of obsolete classifications, and occupational code and title changes. The pay rates reflected in the Pay Plan will be administered in accordance with the provisions of the Living Wage Ordinance 99-44 and the terms and conditions of the applicable bargaining unit agreements.

MIAMI-DADE AVIATION DEPARTMENT PROMOTIONAL FUNDS RECOMMENDED EXPENDITURES Fiscal Year 2017 - 2018

The Budget Ordinance also includes recommendations for Aviation Department Promotional Fund Expenditures totaling \$297,600. As the date of the approved events/program approaches, the Aviation Department will obtain the documentation required by A.O.7-32 from each entity for review by the Aviation Department and the County Attorney's Office prior to disbursement of funds, and in accordance to the following recommendations.

1. Miami-Dade County Aviation Department (MDAD)

Event: Inaugurals for new airlines & routes

Amount recommended: \$18,500

The Aviation Department will co-host inaugural ceremonies for and with new airlines commencing service and with incumbent airlines commencing new routes.

2. Miami-Dade County Aviation Department (MDAD)
Event: Community & Global Outreach Programs

Amount recommended: \$122,100

MDAD, in accordance with FAA guidelines, will utilize airport revenues in support of community and global outreach activities as long as such expenditures are directly and substantially related to the operations of Miami International Airport and MDAD's General Aviation airports. Activities include, among others, Africando, The Florida Chamber's International Days in Tallahassee, The Florida Chamber's International Trade & Investment Summit in Miami, The Beacon's Council's Annual Business Achievements Event and Annual Report Event, the Miami-Dade Chamber of Commerce events, the Florida Customs Brokers & Forwarders Association general monthly meeting sponsorship and Board Installation Event, the Greater Miami Convention & Visitors Bureau Annual Report Event, The Greater Miami Chamber of Commerce's Annual Meeting and World Trade Logistics Conference, The International Air Cargo Association's (TIACA) Annual General Meeting, the International Air Transport Association's (IATA) Annual General Meeting, the annual China Air Cargo Summit, the E-Merge Americas Annual Conference, and the World Trade Center - Miami World Trade Month Events and International Trade Achievement Awards event. These expenditures will be documented and reviewed on a case-by-case basis to ensure compliance with FAA guidelines.

3. Airport Minority Advisory Council (AMAC)

Event: Annual Airport Business Diversity Conference

Amount recommended: \$5,000

The AMAC promotes the full participation of minority and women-owned businesses in airport contracts and promotes the employment of minorities and women in the airport industry. On a yearly basis, MDAD pledges \$5,000 to the AMAC to sponsor their Annual Airport Business Diversity Conference. This sponsorship entitles MDAD to free conference registrations, a half page ad in the conference's journal, and an exhibit booth. The AMAC annual conference is co-sponsored by the FAA and has become one of the largest aviation conferences in the United States. The event brings together businesses, aviation professionals, government officials and individuals from around the country to discuss a variety of subjects ranging from how to do business at airports to public policy issues impacting the entire aviation industry.

4. Miami-Dade County Aviation Department

Event: MIA 90th Anniversary

Amount recommended: \$50,000

MDAD will sponsor a commemorative event at MIA celebrating the 90 years of operation of Miami International Airport, once Pan Am Field.

5. Miami-Dade County

Event: Miami-Dade County Days in Tallahassee 2018

Amount recommended: \$3,500

Miami-Dade Days provides a unique opportunity for participants, including local officials and community leaders to discuss legislative priorities affecting Miami International Airport with state legislators in an informal setting.

6. Florida Airports Council (FAC)

Events: FAC State Legislative Summit, the FAC Federal Legislative Summit and

the FAC Annual Conference

Amount recommended: \$9,000

MDAD will co-sponsor during the FAC State and Federal Summits, as well as the Annual Conference, at which the Department is represented by its Office of Governmental Affairs and the Departmental liaison to FAC.

7. Miami-Dade County Aviation Department (Airside Operations)

Event: FAA Meetings for FY 2017 - 2018

Amount recommended: \$5,000

Airport safety assessment with FAA, airlines, and Chief Pilots; Runway Safety Action Team/FAA meetings with airlines and Chiefs Pilots; FAA drills/meetings reference required drills to meet MIA's 139 Certification as a Commercial Airport; AAAE Trainings regarding required FAA drills to meet MIA's 139 Certification as a Commercial Airport.

8. U.S. Dept. of Commerce's Minority Business Development Agency (MBDA) Event: National Minority Enterprise Development Conference (MEDWeek) Amount recommended: \$4,500

MEDWeek is South Florida's annual Business Opportunity Conference & Matchmaker Expo for Small, Minority, Women and Veteran-owned businesses, government agencies, and corporations. The conference is sponsored by the U.S. Department of Commerce. MDAD has been a participant from its inception to network with other minority-owned and operated enterprises and to showcase and discuss minority business opportunities at MDAD.

8. Miami-Dade County Aviation Department

Event: Survival Fire Drill

Amount recommended: \$5,000

The survival drill is conducted by The Fire Department of Miami-Dade County Aviation Department to review safety practices.

9. Foundation for Democracy in Africa (FDA)

Event: U.S. Africa Air Transportation Summit

Amount recommended: \$25,000

Miami is poised to be the gateway to the U.S. for Africa for air service development in conjunction with the FDA and as such, the major economic beneficiary from related future growth. Through the summit, the Miami-Dade Aviation Department will continue to promote air service and cargo trade between the two continents via Miami International Airport.

10. World Trade Center Miami

Event: Air Cargo Americas International Congress and Exhibition Amount recommended: \$50,000

Air Cargo Americas is a biennial forum for aviation executives to exchange views, develop strategies to enhance the growth of the air cargo industry in the Americas, and showcase the latest products and technologies. MDAD will co-host the trade event in November 2017.

In summary, these events will provide Miami-Dade County's Aviation Department an excellent opportunity to showcase and promote Miami International Airport and its General Aviation airports. All promotional funds recipients will be required to comply with the requirements of Administrative Order 7-32 governing the expenditure of Miami-Dade County Aviation Department promotional funds, and with the Federal Aviation Administration's guidelines.

Seaport Promotional Fund Recommended Expenditures FY17-18

As incorporated in Administrative Order 7-32 are recommendations for Seaport Promotional Fund expenditures totaling \$540,000 to support the following maritime industry related events. These funds will be transferred to the appropriate entities pursuant to execution of standard agreements approved by the County Attorney's Office. Expenditures of such funds shall be spent in accordance with the budgets submitted as part of the standard agreements. In some instances, the funds will be spent directly by the County as set forth below.

1. Greater Miami Convention and Visitors Bureau (GMCVB)

Event title:

Promotional Program

Amount recommended:

\$ 75,000

This funding has been allocated towards promoting several key programs including a Cruise Miami program to increase the number of pre- and post- stays in Miami-Dade County for cruise passengers. These funds include an allocation towards cruise familiarization events/tours for travel agents in partnership with the GMCVB and cruise lines, cruise/tourism trade shows, collateral material, development and production of marketing campaigns/ads for the Port's cruise and cargo business, and other related joint-marketing efforts.

2. PortMiami Promotional Events and Customer Appreciation Activities

Event title:

Miscellaneous Services Related to Preparation for Promotional

Events and Customer Appreciation Activities

Amount recommended:

\$45,000

Throughout the year, promotional events/activities arise where PortMiami elects to participate as a sponsor or host site. These events provide Miami-Dade County an excellent opportunity to showcase its seaport facilities for both cargo operations and passenger accommodations as hemispheric hubs for international trade and tourism. The Port will host customers at such events either on-Port or at off-Port locations.

3. Latin Chamber of Commerce (CAMACOL)

Event title:

Hemispheric Congress

Amount recommended:

\$50,000

The Latin Chamber of Commerce (CAMACOL) is the largest Hispanic business organization in Florida. CAMACOL's mission is to foster entrepreneurship of Florida's Hispanic and minority communities, and as such, it conducts local business programs to promote economic development and facilitate commerce.

The Hemispheric Congress is a successful conduit for interaction among the business communities of the Americas. Several programs designed to enhance trade relations in the hemisphere have been developed as a result of the conference. The support of funds enables the Congress to strengthen multi-lateral trade, and develop markets for U.S. products. This event benefits Miami-Dade County by promoting trade to strengthen our local economy.

4. Florida International University

Event title: Inter-American Conference of Mayors

Amount recommended: \$35,000

The aim of this conference is to strengthen democracy in the hemisphere by creating opportunities for discussion among local leaders and those interested in local government. It provides a forum for discussion of common issues and varied experiences, which enables participants and communities to learn from one another. The event benefits our community by showcasing Miami-Dade County and its authorities as key resources in strengthening local government throughout the Americas.

5. Seatrade Cruise Global Exhibition & Conference

Event title: Conference, Trade Show, and related events

Amount recommended: \$60,000

Seatrade Cruise Global Exhibition & Conference (formerly named Cruise Shipping Miami) is the premier annual convention in the cruise industry. It has been in existence for over 30 years and attended regularly by over 10,000 participants, including more than 1,800 cruise line owners and operators from 66 cruise line companies. Funds for this event will be spent on conference registration, educational seminars, trade show set-up, promotional materials, Florida Caribbean Cruise Association (FCCA) Gala Dinner, and related events.

6. American Association of Port Authorities (AAPA) Latin American Ports Delegation

Event title: Annual Congress

Amount recommended: \$20,000

This AAPA annual convention provides the opportunity to address and discuss common issues facing ports in Latin America and PortMiami. Expected discussions include the impact of the Panama Canal, vessel sizes, general economic business, importation/exportation of perishable products grown in Latin America, port financing and maritime security and training. The conference and trade show provide a forum for the exchange of ideas and experiences as well as a venue for port representatives, operators, service providers and maritime industry leaders.

7. Cargo & Cruise Marketing Program

Event title: Promotional Program

Amount recommended: \$ 120,000

This funding will go towards developing strategic campaigns over multiple communication platforms in support of the Port's cargo and cruise business. The program will include intermodal, trade and logistics marketing efforts, as well as cruise marketing efforts, in conjunction with the Port's cruise and cargo customers. PortMiami will welcome several new cruise ships to its line-up in Fiscal Year 2017/18 and of this funding will be allocated towards inaugural events and/or promotions.

8. Florida Customs Brokers & Forwarders Association (FCBF)

\$25,000

The Florida Customs Brokers & Forwarders Association, Inc. (FCBF) is an extremely influential and active representative body of the Florida freight forwarding and customs brokerage community. Through its numerous committees of volunteer professionals, the FCBF represents the trade and logistics industries on matters that directly affect the trade arena. FCBF fosters communications between the trade community and the federal agencies in order to expand Florida's trading communities at the local, state, and national level. FCBF maximizes the ability of the State of Florida to effectively compete for international trade resources and to minimize the barriers for international trade and logistics. Funds will be spent on sponsoring the FCBF Annual Conference, seminar/training programs, events and monthly meetings.

9. Miami Children's Museum (MCM)

Miami Children's Museum (MCM) has become a central gathering place for children and families, serving 430,000 last year and over 2.5 million since opening of the facility on Watson Island in 2003. The PortMiami exhibit is one of the most popular and most utilized by MCM's visitors. Funds will be allocated towards renovations of the PortMiami Exhibit Gallery. Such renovations include: refurbishing the existing Gantry Crane interactive, refurbishing the Remote Control Tugboats, installation of the PortMiami Tunnel Entry, creation of an interactive video component featuring PortMiami transportation modalities, and creation of new activities to enhance the visitor experience, including balance the Barge Interactive on an FEC train

10. Florida Perishables Trade Coalition (FPTC)

Amount:

\$15,000

The Florida Perishables Trade Coalition (FPTC) is a non-profit association focusing on the collective experience and efforts of industry leaders from throughout the state to increase trade in perishable products through Florida's airports and seaports. It formally organized in 2012 to expand upon the work and support the efforts of an informal trade coalition which has identified and worked on these issues over the last year. Members of the FPTC direct the efforts to grow perishable trade in Florida ports by addressing the cold treatment, reviving perishable logistics workshops, and undertaking new initiatives identified by FPTC members as needed to make agricultural trade grow and prosper in Florida ports.

11. Miami-Dade Beacon Council

The Beacon Council is Miami-Dade County's official economic development organization focusing on job creation and economic growth. The Beacon Council facilitates local, national and international business growth and expansion programs. The Beacon Council is a major supporter of the maritime industry, specifically critical to PortMiami's initiatives, including trade & logistics and hospitality & tourism. Funds will be allocated towards promoting Miami-Dade County as a center for trade and logistics with support and participation in targeted events to drive growth through our business community.

PortMiami, the closest U.S. port to Africa, is working to develop a trade strategy with Africa with the goal of adding direct cargo services. With this initiative, PortMiami will host an Africa Ports Summit (APS) in fall of 2018. APS's participants include port authorities, terminal operators, freight forwarders, shipping associations, trade and logistics companies, and shipping lines. The conference will highlight growth opportunities for trade between PortMiami and Africa, the accomplishments of the affiliated Sister Seaports, and PortMiami's successful infrastructure projects. Funds for this event will be spent on marketing/conference materials, promotional materials, transportation, food and beverage, and other conference-related items.

13. International Longshoremen's Association (ILA)

Event Title:

South Atlantic & Gulf Coast Convention

Amount:

\$25,000

The International Longshoremen's Association, AFL-CIO is the largest union of maritime workers in North America, representing approximately 65,000 longshoremen on the Atlantic and Gulf Coasts, Great Lakes, major U.S. rivers, Puerto Rico and Eastern Canada. Among the roles of the ILA are the loading and unloading of container ships and servicing cruise passenger vessels in Florida and throughout the district. The South Atlantic & Gulf Coast District is a division of the union representing longshoreman workers in ports from North Carolina to Texas, including PortMiami. Funding towards this program will be allocated towards sponsoring the South Atlantic & Gulf Coast Convention which will be attended by approximately 800 longshoremen workers during summer 2018 in Miami-Dade County.

This memorandum accompanies the FY 2017-18 Budget Ordinances for your consideration at the Second Budget Hearing on September 28, 2017. This document provides information requested and recommendations for other adjustments for Board of County Commissioners (Board) consideration. The total of all adjustments approved at the first budget hearing and included in this memorandum, not including special taxing districts, is \$9.86 million and represents 0.2 percent of the total operating budget.

During the First Budget Hearing on September 19, 2017, the Board approved the tentative millage rates I proposed: Countywide 4.6669, Unincorporated Municipal Services Area 1.9283, Fire Rescue Service District 2.4207, and Library System 0.284 mills. These rates cannot be increased. At these millage rates, the Proposed Budget is funded and the adjustments included in this memorandum may be supported.

Carryover and Hurricane Irma Reserve

As I recommended in my remarks at the beginning of the first budget hearing, we are increasing budgeted carryover by \$2 million to recognize the additional sales tax funding we anticipate receiving as a result of preparation for Hurricane Irma, as well as post-storm purchases. The additional funding is budgeted as a Hurricane Irma Reserve to address issues that may impact the County in FY 2017-18, such as reduced revenues and unreimbursed recovery expenses. We anticipate that additional People's Transportation Plan (PTP) Surtax and Public Health Trust Surtax will also accrue to those funds. The additional funding in PTP Surtax will be necessary to offset continued losses in farebox revenues beyond what had been previously reported. Additional revenue in PHT surtax will help improve the PHT cash position.

Budgeted carryover will also be increased by \$1.2 million due to improved expenditure projections in the Police Department. I recommend \$1.09 million be allocated as described in this memorandum below and \$110,000 be allocated to the Hurricane Irma Reserve for a total of \$2.11 million.

Department of Transportation and Public Works (DTPW)

At the First Budget Hearing, the Board made it clear that your priority for funding was public transportation. I share your opinion that in order to be a truly resilient community now and in the future, we must solve our mobility issues. The Board is well aware of the challenges we have faced to support a system, which in the past has not been adequately maintained, and due to a decline in ridership (just as other transit properties around the country have experienced), has seen a reduction in farebox revenue. In July, the Board approved a number of service adjustments necessary to balance both the FY 2016-17 and FY 2017-18 budgets for DTPW. Even with these changes, the FY 2016-17 budget does not include funding for a retroactive payment for a cost of living adjustment (COLA) for the Transport Workers Union (TWU) members. The FY 2017-18 budget includes funding for a COLA beginning in October 2017.

The FY 2017-18 Proposed Budget continued the reductions approved by the Board, along with further service adjustments that may be implemented administratively. Clearly, the Board is not supportive of the further reductions included in the Proposed Budget and is supportive of restoring the service to the Metrorail system that were adjusted in March 2017. The cost of restoration of the bus and Metrorail service is \$13.46 million. My administration has developed the following options to buy back these services.

One of the conditions that has caused the challenges to our farebox recovery ratio (the amount of revenue generated by the system riders) is the implementation by municipalities of free or low cost circulator service which duplicates a portion of our revenue generating routes, as well as circulators we operate adjacent to bus routes. I recommend that we eliminate those routes we operate for which duplicate service exists. There are two routes that may be eliminated, for which riders have an alternative, and two routes that will be adjusted saving a total of \$4.408 million. Furthermore, there are 6 holidays for which Sunday service is provided and 5 holidays for which regular service is run. I recommend Sunday service be provided for all County holidays, saving another \$2.604 million. I also recommend fully restoring funding for Metrorail service (\$4.8 million). As we bring in our new train cars, service reliability will improve.

At this time. I also recommend amending the People's Transportation Plan (PTP) to substitute half of the contribution to the Capital Expansion Reserve Fund from PTP surtax with available Road Impact Fees. In March 2009, as part of the legislation allowing for unification of the funding for the existing transit service, the Board approved R-222-09, sponsored by Commissioner Jordan, to amend Exhibit 1 of the PTP and require that at least ten (10) percent of the County's share (which excludes the municipal share) of surtax funds, excluding present and future debt service obligations, be dedicated to capital expansion of the transit system. This Capital Expansion Reserve Fund has a current projected balance of \$66.195 million, minus a final payment of \$3.1 million for the Miami Central Station and the \$12 million cost for planning, design, and engineering studies for the SMART Plan, which are contemplated in the FY 2017-18 Budget. The budgeted contribution for FY 2017-18 to this reserve is \$11.074 million. My recommendation is to amend the PTP from this point forward to reduce the minimum PTP surtax revenue contribution from ten (10) to five (5) percent, provided available Road Impact Fee revenues in an amount equal to five (5) percent of the County's share of PTP surtax revenues (excluding debt service obligations) are allocated to the Capital Expansion Reserve Fund. It is understood that the availability of road impact fees for any particular project is subject to the requirements of Section 33E-12 of the Code. This amendment would free up half of the PTP surtax transfer (\$5.537 million in the current year) to support operations this year and in the future and would maintain the projected growth in the Capital Expansion Reserve Fund to be utilized for the SMART Plan. A resolution effectuating this amendment to the PTP will be brought to the Board for consideration after presentation to the CITT. Should the CITT not agree to the amendment, approval of the amending resolution would require a two-thirds vote of the full Board. Furthermore, if the Board does not approve an amendment reducing to five (5) percent the minimum PTP surtax revenue contribution to the Capital Expansion Reserve Fund, and ten (10) percent of the County's share of Surtax funds is not otherwise allocated to the Capital Expansion Reserve Fund, prospectively, among other potential consequences, unification of the funding for the existing transit service would cease and future use of PTP surtax revenues for operations and maintenance would be limited.

Along with \$911,000 in additional reductions to overhead expenses and the adjustments outlined above (totaling \$7.012 million), we will not have to make further reductions at this time.

The appropriate agenda items and public hearing notices to effectuate the change in the People's Transportation Plan and the changes to the four routes will be prepared for consideration by both the Citizens' Independent Transportation Trust and the Board, as required, on a future meeting agenda.

Animal Services Department (ASD)

At the First Budget Hearing, the Board expressed an interest in increasing the number of surgeries done as part of the Trap, Neuter and Release (TNR) program. The Humane Society of Greater Miami has not fully utilized its grant allocation, primarily related to the number of feline surgeries performed. I recommend that \$200,000 not utilized by the Humane Society be reallocated within ASD's budget so that the County can perform in-house spay/neuter surgeries as part of the TNR program. Should additional staff be required, positions adjustments will be made during the fiscal year.

Miami-Dade Police Department (MDPD)

MDPD informed the Office of Management and Budget last week that they would be underspending their most recent projection by \$1.2 million due to higher than anticipated civilian attrition. I recommend we utilize this funding to schedule an additional basic law enforcement class (\$500,000), restoration of the maintenance cycles in the Parks, Recreation and Open Spaces (PROS) department (\$340,000), \$250,000 for additional tree canopy (for a total of \$1 million for tree canopy restoration in the budget), and \$110,000 to the Hurricane Irma Reserve as described above. At the end of FY 2017-18, MDPD will have increased filled sworn positions by 65. MDPD will continue to provide a preference to veterans applying for Police Officer positions.

Parks, Recreation and Open Spaces (PROS)

On September 19, 2017, the Board adopted the Special Taxing District rates which decreased and/or remained flat for street lighting, security guard, multipurpose maintenance, and capital improvement/road maintenance. Attachment A details the appropriation schedules as approved by the Board. As the Board is aware, there are still a number of special taxing districts that required a proposed rate increase. Those districts have been removed from the budget ordinance schedules, which results in a \$32.678 million reduction to Fund SO 900, in various subfunds (street lighting district \$12.374 million, Security Guard District \$15.705 million, and Multipurpose Maintenance District \$4.599 million). The districts for which rates have not be approved will be presented to the Board on October 17, 2017. A budget supplement will be presented to the Board for consideration once final action has been taken on pending special taxing districts rate adjustments. Staff continues to work with residents of the affected districts to explain adjustments and resolve pending issues prior to the Board's final consideration.

Parks, Recreation and Open Spaces (PROS) (Cont.)

As mentioned above, I recommend \$340,000 be allocated to restore median maintenance cycles to current year budgeted levels. Medians will continue to be maintained 17 times per year. I also recommend an additional \$250,000 be allocated for tree canopy restoration, which is not FEMA reimbursable. The total FY 2017-18 budget for tree canopy restoration will be \$1 million.

Library

The Proposed Budget included funding for 900 hours of tutoring at our Main and regional library branches (Miami Beach, North Dade, South Dade, West Dade, and West Kendall). I recommend expanding the program to other branches throughout the County, increasing the number of tutoring hours at this time to 3,350. Homework assistance services for students will be provided at an additional 12 branch locations (Allapattah, Arcola Lakes, Coral Gables, Homestead, International Mall, Kendale Lakes, Kendall, Miami Lakes, Model City, Naranja, Northeast Dade-Aventura, and West Flagler). As a result, the Homework Assistance Program budget will be increased by \$270,000, from \$30,000 to \$300,000 and one full-time position will be added to oversee this expanded program in FY 2017-18. Funding is provided by reducing Library operating reserves by \$270,000.

Department of Solid Waste Management (DSWM)

At the September 19, 2017 Special meeting, the Board approved various adjustments to the Solid Waste Collection Service area fees, including an additional \$6.00 per residential household to respond to illegal dumping collection throughout the County (\$1.925 million). DSWM will add four crews (13 positions) dedicated to illegal dumping. In addition, Administrative Order 4-68 has been amended to reflect the approved fees (Attachment B).

Community-based Organizations (CBOs)

At the First Budget Hearing, the Board approved a motion to allocate budgeted funding for CBOs based upon Option B suggested in my August 22, 2017 memorandum "Options for Allocations to Community-based Organizations." Those allocations for programmatic support are listed alphabetically by agency as Attachment C. In order to fully fund the allocations, \$975,000 would be transferred from the Community-based Organizations Discretionary Reserve (Proposed Budget, Volume 1, page 141) to the Community-based Organizations allocation (Proposed Budget, Volume 1, page 140). The balance in the CBO Discretionary Reserve would be \$1.625 million or \$125,000 per Commission District for allocation to community-based organizations for district specific needs. The total funding for CBOs awarded through the competitive process adjusted by Option B would be \$13.82 million.

The Mayor or the Mayor's designee is hereby authorized to <u>negotiate and</u> execute agreements for funding allocations for community-based organizations and Mom and Pop Program participants approved in this ordinance as a result of a request for proposals or other formal selection process <u>or other allocations</u>, including individual allocations, approved by the Board in the form approved by the County Attorney.

In the event staff is unsuccessful in either executing contracts with agencies or agencies are not successful in drawing down funds during the fiscal year, unused funding will be reserved for reallocation in FY 2018-19.

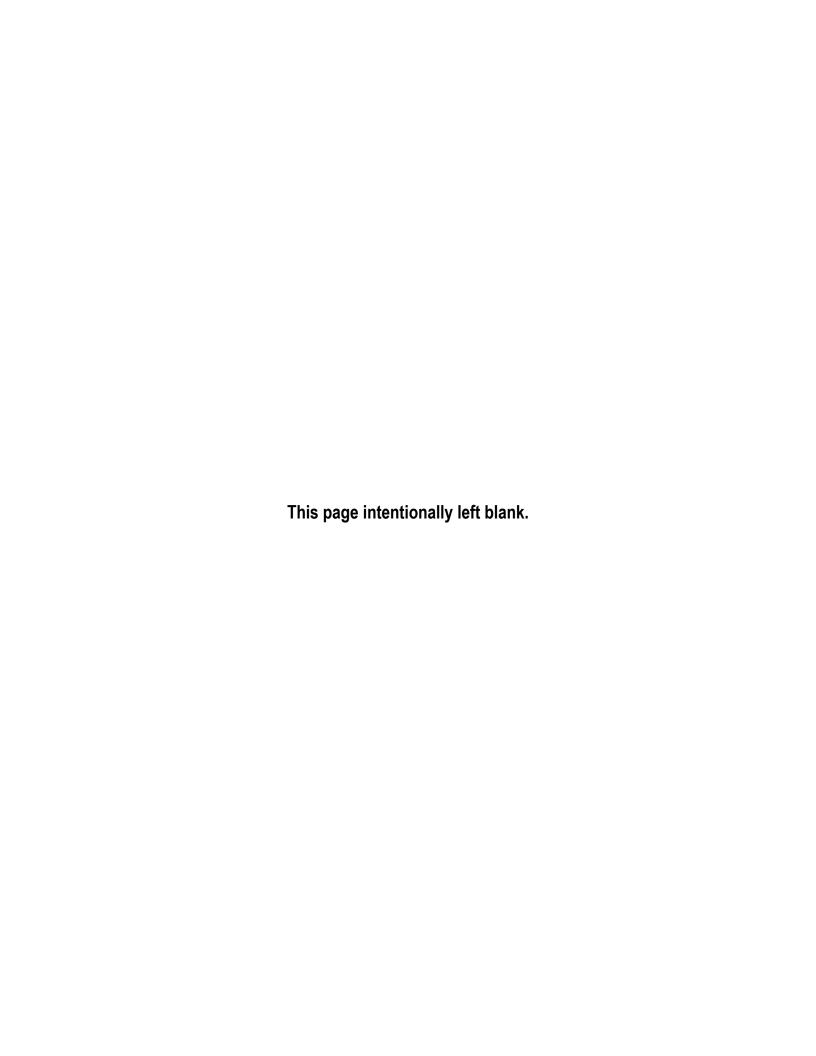

MIAMI-DADE COUNTY IMPLEMENTING ORDER

SCHEDULE OF ALL SERVICE LEVELS AND FEES FOR MIAMI-DADE COUNTY SOLID WASTE SERVICES

AUTHORITY:

Section 5.02 of the Miami-Dade County Home Rule Amendment and Charter The Miami-Dade County Home Rule Charter, including among others, Sections 1.01 and 2.02A, and Chapter 15 of the Code of Miami-Dade County.

SUPERSEDES:

This Implementing Order (IO) supersedes IO 4-68, ordered <u>September 19, 2015-September 22, 2016, 2016</u>, and effective October 1, 201<u>765</u>

POLICY:

This Implementing Order provides a schedule of all solid waste service levels and fees.

PROCEDURE:

The administration of this Implementing Order is designated to the Director of the Miami-Dade County Department responsible for Solid Waste Management, who shall be responsible for the collection of fees and the delivery of the required services, pursuant to Chapter 15 relating to powers and duties of Solid Waste Management. Every year, or earlier, if need be, the Director shall review all fees in terms of cost and recommend necessary changes to the County Mayor through this implementing order procedure.

DEFINITIONS:

Contract Disposal – use of the County Waste Management System by any person, governmental entity, corporation or partnership that has entered into an Agreement with the County of ten (10) years or greater in duration for such County Solid Waste Management System use.

Short Term Disposal – use of the County Waste Management System by any person, governmental entity, corporation or partnership that has not entered into an Agreement with the County of ten (10) years or greater in duration for such County Solid Waste Management System use.

FEE SCHEDULE:

The fee schedule adopted by this Implementing Order is attached hereto and made a part hereof. This official fee schedule is also filed with and subject to the approval of the Board of County Commissioners and on file with the Clerk thereof. Fees that are charged by the County shall be the same as those listed in the official fee schedule on file with the Clerk of the County Commission.
