Subject: Ratification of Emergency Orders Issued in Response to COVID-19 Pandemic

Agenda Item No. 12(A)(1)

Resolution No. R-328-20

As you are all aware, I have signed a series of emergency orders and amendments to protect the health, safety and well-being of the 2.8 million residents of Miami-Dade County since first declaring a local State of Emergency due to the COVID-19 pandemic on March 12, 2020. These orders are posted on the miamidade.gov/coronavirus website, and I have also attached them as part of this memorandum for your convenient reference. Following is a quick summary of my Emergency Orders signed to date:

- Emergency Order 01-20 ordered the closure of certain congregate meal sites and community centers and directed County staff to provide food service for the duration of the state of emergency.
- Emergency Order 02-20 ordered the closure of restaurants, bars, taverns, pubs, night clubs, banquet halls, cocktail lounges, cabarets, breweries, cafeterias and any other alcohol or food service establishments between 11 p.m. and 6 a.m., with certain exceptions for grocery stores, delivery services, and similar operations.
- Emergency Order 03-20 ordered the closure of restaurants, bars, taverns, pubs, night clubs, banquet halls, cocktail lounges, cabarets, breweries, cafeterias and any other alcohol or food service establishments at all hours, with certain exceptions for grocery stores, delivery services, and similar operations.
- Emergency Order 04-20 prohibited gatherings of more than 10 people in any parks, beaches, or recreation facilities owned or operated by Miami-Dade County.
- Emergency Order 05-20 prohibited the use of mopeds, common use motorized scooters, common use motorized bicycles, common use bicycles or any micromobility device on any public street or sidewalk within the limits of Miami-Dade County.
- Emergency Order 06-20, as amended, ordered the closure of all parks, beaches, and recreational facilities in the incorporated and unincorporated areas of Miami-Dade County.
- Emergency Order 07-20, as amended, ordered the closure of all non-essential retail and commercial establishments.
- Emergency Order 08-20 prohibited rafting, defined as the practice of tying together boats and vessels when the proximity is five feet or less, with certain emergency exceptions.
- Emergency Order 09-20, as amended, ordered hotels, motels, short-term vacation rentals and other commercial lodging establishments to not accept new reservations for persons other than essential lodgers, as defined in the order and further ordered short-term vacation rentals to limit their occupancy and no longer accept nightly or weekly rental agreements.

- Emergency Order 10-20 prohibited gatherings of 10 or more individuals on public streets, alleys, public ways, sidewalks or government facilities open to the public, with certain exceptions.
- Emergency Order 11-20 urged persons over 65 years of age and persons with serious underlying medical conditions that place them at a high risk of severe illness to stay home and take such other measures as necessary to limit their risk of exposure to COVID-19.
- Emergency Order 12-20 ordered the totality of the Mayor's Emergency Orders be referred to as the "Safer at Home" protocols and urged all residents and visitors to remain in their homes other than to engage in essential activities as outlined in the "Safer at Home" protocols.
- Emergency Order 13-20 ordered all essential commercial and retail establishments in Emergency Order 07-30 to use reasonable efforts to maintain appropriate social distancing, particularly in checkout, pick-up or take-out areas, employee breakrooms and common use areas.
- Emergency Order 14-20 ordered suspension of all laws, statutes, codes and regulations relating to County employees performing building code functions, including, but not limited to, the review of plans, issuance of permits, performance of inspections and issuance of certificates of occupancy and completion and temporary certificates of occupancy, and all activities related thereto.
- Emergency Order 15-20 ordered closure of all pools, hot tubs, golf courses, tennis courts, basketball courts, fitness centers, gymnasiums and other common use amenities, whether of a commercial or non-commercial nature, for all purposes.

These orders in their totality reinforce the day-by-day monitoring approach that my administration and I took in consultation with medical experts to protect our community every step of the way, while allowing essential activity to continue to take place, as necessary.

As of the date of this memorandum, we have reached a point where I must articulate the need for all residents to stay at home except for when there is a need to perform essential activities like going to a medical appointment, getting gas, groceries or prescriptions from pharmacies, and to practice social distancing at all times, even within families. We are indeed "Safer at Home" as a community, and medical experts agree that this is the best way to prevent the spread of COVID-19 in the long term.

Pursuant to Section 8b-7 of the Miami-Dade County Code, all of the orders that I have signed since March 12, 2020 require ratification by the Board of County Commissioners. Therefore, I respectfully request that you ratify these orders so that we can continue to slow down the spread of COVID-19 in our community. I will continue to monitor the spread of the virus in consultation with our health and public safety experts, and will sign additional orders that are in the best interest of our entire community as this pandemic evolves. Thank you for your support.



MIAMI-DADE COUNTY DECLARATION OF LOCAL STATE OF EMERGENCY

WHEREAS, Section 252.38(3)(a), Florida Statutes, gives authority to political subdivisions to declare and enact a State of Local Emergency for a period of up to seven (7) days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, on March 1, 2020, the Governor of Florida issued Executive Order Number 20-51 directing the State Health Officer and Surgeon General to declare a Public Health Emergency due to the discovery of COVID-19/novel Coronavirus in Florida; and

WHEREAS, on March 9, 2020, the Governor of Florida issued Executive Order Number 20-52, declaring a State of Emergency for the state of Florida related to COVID-19/novel Coronavirus; and

WHEREAS, COVID-19/novel Coronavirus poses a health risk to Miami-Dade County residents, particularly elderly residents; and

WHEREAS, responding to the threat posed by COVID-19/novel Coronavirus may require extraordinary and immediate actions by Miami-Dade County in order to protect the public health, safety, and welfare,

THEREFORE, as County Mayor of Miami-Dade County, I hereby declare a State of Local Emergency, effective as of 9:00 AM March 12, 2020, that will continue for seven (7) days thereafter or if cancelled before that period of time. This Local State of Emergency includes all of Miami-Dade County.

Pursuant to this Declaration, further orders may be issued to protect the health, safety, and welfare of the community. Such orders may include, but are not limited to, orders related to the items listed in 1.a-p attached. The Deputy Mayors, through the Director of the Office of Emergency Management, are hereby ordered to take whatever prudent actions are necessary to effectuate such orders and to otherwise protect the health, safety, and welfare of the community.

Action Options for State of Local Emergency

1. Executive Orders of the Mayor to include:
 - a) Employee Recall order: An order recalling Miami-Dade County employees from vacation, canceling days off, and mobilizing all personnel required for disaster response;
 - b) Authorizing the Internal Services Department to suspend normal leasing and bid procedures to procure space, structures or other items under their normal authority for disaster response determined necessary by the Director;
 - c) Authorizing procurement of supplies, equipment, and services without formal bidding procedures;
 - d) Evacuation Order: A mandatory order(s) directing the evacuation of appropriate area(s) of the County deemed to be in imminent danger from disaster;
 - e) Curfew: In the period before, or during and immediately after an event, an order imposing a general curfew applicable to the County as a whole, or to geographical area(s) of the County and during hours the Mayor deems necessary, and from time to time, to modify the hours the curfew will be in effect and what area(s) it applies to;
 - f) An order requiring any and all commercial establishments located in area(s) of imminent or actual danger to close and remain closed until further order;
 - g) An order requiring the closure of any or all bars, taverns, liquor stores, and other business establishments where alcoholic beverages are predominantly sold or otherwise dispensed; provided that with respect to those business establishments which are not primarily devoted to the sales of alcoholic beverages, and in which such alcoholic beverages may be removed or made secure from seizure by the public, the portions thereof utilized for the sale of items other than alcoholic beverages may, at the discretion of the Mayor, be allowed to remain open;
 - h) An order requiring the discontinuance of the sale, distribution or giving away of alcoholic beverages in any or all parts of Miami-Dade County;
 - i) An order requiring the discontinuance of the sale, distribution or giving away of gasoline or other liquid flammable or combustible products in any container other than a gasoline tank properly attached to a gas powered vehicle;

- j) Intentionally Omitted;
- k) An order closing to the public any or all public places including streets, alleys, public ways, schools, parks, beaches, amusement areas and public buildings;
- l) In addition to the provisions of Chapter 8A-5 of the Code of Miami-Dade County, orders to prevent price gouging for any essential commodity, dwelling unit, or storage facility;
- m) Orders requesting the conservation of water supplies;
- n) Such other orders as are immediately necessary for the protection of life and property; provided, however, that any such orders shall, at the earliest practicable time, be presented to the Board for ratification or confirmation in accordance with chapter 8B.
- o) The Mayor shall cause any proclamation ordered by the Mayor or the Board pursuant to the authority in this chapter to be delivered to all news media within the County, and shall utilize whatever available means to give public notice of such proclamation.
- p) The Mayor is hereby authorized to cancel any or all meetings of Miami-Dade County boards, authorities, agencies, instrumentalities and councils.

MIAMI-DADE COUNTY EMERGENCY ORDER 01-20

WHEREAS, Section 252.38(3)(a), Florida Statutes, gives authority to political subdivisions to declare and enact a State of Local Emergency for a period of up to seven (7) days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, on March 1, 2020, the Governor of Florida issued Executive Order Number 20-51 directing the State Health Officer and Surgeon General to declare a Public Health Emergency due to the discovery of COVID-19/novel Coronavirus in Florida; and

WHEREAS, on March 9, 2020, the Governor of Florida issued Executive Order Number 20-52, declaring a State of Emergency for the state of Florida related to COVID-19/novel Coronavirus; and

WHEREAS, on March 12, 2020, a State of Emergency was declared for all of Miami-Dade County; and

WHEREAS, COVID-19/novel Coronavirus poses a health risk to Miami-Dade County residents, particularly elderly residents; and

WHEREAS, Congregate Meal Sites and Community Centers as listed on Exhibit A hereto are locations where elderly residents interact for long periods of time; and

WHEREAS, minimization of contact is necessary to avoid risk of COVID-19 infection for the elderly community in Miami-Dade County; and

WHEREAS, the closure of Congregate Meal Sites and Community Centers is necessary in order to protect the public health, safety, and welfare,

THEREFORE, as County Mayor of Miami-Dade County, I hereby order:

1. The Congregate Meal Sites and Community Centers listed on the attached Exhibit A, and any other facility providing meal services to the elderly pursuant to authorization by the Department of Elder Affairs are hereby ordered to close, or otherwise cease all programs to deliver personal services to the elderly, effective March 16, 2020. Notwithstanding, staff employed at such sites may continue business operations which do not involve the delivery of personal services to the elderly population. This order does not apply to Assisted Living Facilities as defined under Chapter 429.02, Fla. Stat, Adult Day Cares as defined under 429.901 Fla. Stat, or Nursing Homes as defined in Chapter 400.021 Fla. Stat.

2. County staff are directed to take all appropriate measures to provide food service during the duration of this Order. Such measures may include the purchase of goods and services, including but not limited to food services, personal protective equipment, delivery services, and refrigerated vehicles, without competitive solicitation as authorized by Executive Order Number 20-52 and the existing Miami-Dade County State of Local Emergency.

3. This Order shall expire upon the expiration of the existing Miami-Dade County State of Local Emergency, except that if such State of Local Emergency is extended, this Order shall also be deemed to extend for the duration of such extension. This Order may be cancelled earlier by action of the County Mayor.

4. This Order shall be provided to all appropriate media consistent with the requirements of Chapter 8B-7(2)(n) of the Code of Miami-Dade County.

MIAMI-DADE COUNTY EMERGENCY ORDER 02-20

WHEREAS, Section 252.38(3)(a), Florida Statutes, gives political subdivisions the authority to declare and enact a State of Local Emergency for a period of up to seven days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, on March 1, 2020, the Governor of Florida issued Executive Order Number 20-51, directing the State Health Officer and Surgeon General to declare a Public Health Emergency due to the discovery of COVID-19/novel Coronavirus in Florida; and

WHEREAS, on March 9, 2020, the Governor of Florida issued Executive Order Number 20-52, declaring a State of Emergency for the state of Florida related to COVID-19/novel Coronavirus; and

WHEREAS, on March 12, 2020, the County Mayor declared a State of Emergency for all of Miami-Dade County; and

WHEREAS, COVID-19/novel Coronavirus poses a health risk to Miami-Dade County residents, particularly elderly residents and those who are immunosuppressed or otherwise have high-risk medical conditions; and

WHEREAS, minimization of contact is necessary to avoid risk of COVID-19 infection for the residents of the County; and

WHEREAS, restaurants, bars, taverns, pubs, night clubs, banquet halls, cocktail lounges, cabarets, breweries, and cafeterias are potential gathering places for the spread of COVID-19/novel Coronavirus; and

WHEREAS, movie theaters and playhouses are potential gather places for the spread of COVID-19/novel Coronavirus; and

WHEREAS, section 8B-7(2)(f) of the Code of Miami-Dade County authorizes the County Mayor to order the closure of any commercial establishment; and

WHEREAS, section 8B-7(2)(g) of the Code of Miami-Dade County authorizes the County Mayor to order the closure of any or all bars, taverns, and other business establishments where alcoholic beverages are predominantly sold or otherwise dispensed; and

WHEREAS, sections 8B-7(2)(e) and (o) authorize the County Mayor to limit the movement of persons inside Miami-Dade County in order to safeguard life and health,

THEREFORE, as County Mayor of Miami-Dade County, I hereby order:

1. 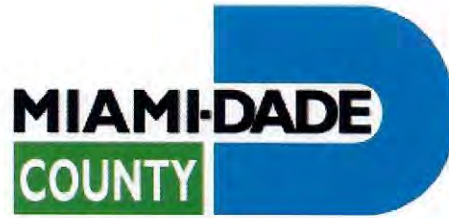

 - d. Businesses that provide food, shelter, social services, and other necessities of life for economically disadvantaged or otherwise needy individuals;
 - e. Newspapers, television, radio, and other media services;
 - f. Gas stations and auto-supply, auto-repair, and related facilities;
 - g. Banks and related financial institutions;
 - h. Hardware stores;
 - i. Contractors and other tradesmen, appliance repair personnel, exterminators, and other service providers who provide services that are necessary to maintaining the safety, sanitation, and essential operation of residences and other structures;
 - j. Businesses providing mailing and shipping services, including post office boxes;
 - k. Private colleges, trade schools, and technical colleges, but only as needed to facilitate online or distance learning;
 - l. Laundromats, dry cleaners, and laundry service providers;
 - m. Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of Emergency Order 3-20. Schools and other entities that typically

- s. Assisted living facilities, nursing homes, and adult day care centers, and senior residential facilities;
- t. Professional services, such as legal or accounting services, when necessary to assist in compliance with legally mandated activities;
- u. Landscape and pool care businesses, including residential landscape and pool care services;
- v. Childcare facilities providing services that enable employees exempted in this Order to work as permitted. To the extent possible, childcare facilities should operate under the following mandatory conditions:
 - 1. Childcare must be carried out in stable groups of 10 or fewer (inclusive of childcare providers for the group).
 - 2. Children and child care providers shall not change from one group to another.
 - 3. If more than one group of children is cared for at one facility, each group shall be in a separate room. Groups shall not mix or interact with each other.

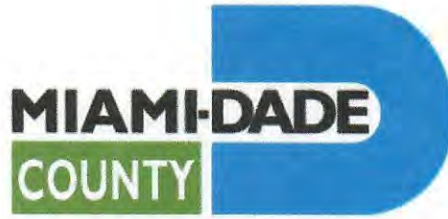

WHEREAS, COVID-19/novel Coronavirus poses a health risk to Miami-Dade County residents, particularly elderly residents and those who are immunosuppressed or otherwise have high-risk medical conditions; and

WHEREAS, minimization of contact is necessary to avoid risk of COVID-19 infection for the residents of the County; and

WHEREAS, the Centers for Disease Control (CDC) has issued guidance entitled “15 Days to Slow the Spread,” encouraging social distancing and maintaining a six (6) foot separation between residents to slow the spread of infection and that events with more than ten attendees either be cancelled or held virtually; and

WHEREAS, the CDC guidelines are based upon the amount of community spread within a community and become more stringent where there is minimal to moderate or substantial community spread; and

WHEREAS, the CDC guidelines encourage the sharing of messages for those who are sick to not attend group gatherings; and

WHEREAS, recreational boaters frequently engage in a practice known as “rafting” where several boats are tied together or otherwise attached within five feet of each other allowing passengers to easily move from boat to boat; and

3. This order does not prohibit the tying together or attaching of one boat to another boat for the limited purpose of rescuing passengers from an emergency or towing an inoperable boat. This order does not apply to boats on the Florida Intracoastal Waterway.

To aid the availability of hotel rooms for (1) healthcare professionals, (2) first responders, (3) National Guard members, (4) law enforcement, (5) state or federal government employees, (6) airline crewmembers, (7) patients, (8) patients' families, (9) journalists, (10) others responding to COVID-19, (11) displaced residents or visitors, (12) persons unable to return their home due to COVID-19 impacts on travel, (13) persons who must vacate their homes due to exigent circumstances, such as fire or flood, (14) persons utilizing hotels as transitional living arrangements, (15) persons sheltering in hotels due to domestic violence, (16) hotel employees, service providers, and contractors, or (17) individuals who, for any reason, are temporarily unable to reside in their home ("Essential Lodgers"), the following restrictions shall apply to commercial lodging establishments:

- (a) Hotels, motels, and other commercial lodging establishments shall not accept new reservations for persons other than Essential Lodgers.
- (b) Hotels, motels, and other commercial lodging establishments may accept reservations for new Essential Lodgers.

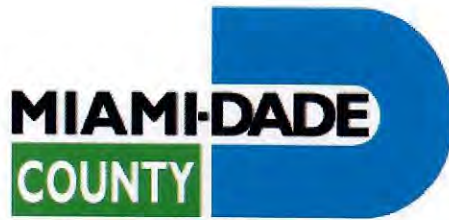

WHEREAS, COVID-19/novel Coronavirus poses a health risk to Miami-Dade County residents, particularly elderly residents and those who are immunosuppressed or otherwise have high-risk medical conditions; and

WHEREAS, minimization of contact is necessary to avoid risk of COVID-19 infection for the residents of the County; and

WHEREAS, the Centers for Disease Control (CDC) has issued guidance entitled "15 Days to Slow the Spread," encouraging social distancing and maintaining a six foot separation between residents to slow the spread of infection and that events with more than 10 attendees either be cancelled or held virtually; and

WHEREAS, individuals continue to congregate in Miami-Dade County on public streets and sidewalks in groups of more than 10, which places residents at risk, and prolongs the need for emergency responses and business closures; and

WHEREAS, essential retail and commercial establishments are expected to manage patrons on their premises consistent with CDC social distancing guidelines, but some are not; and

WHEREAS, section 8B-7(2)(k) of the County Code authorizes the County Mayor to issue an order closing to the public any or all public places including, streets, alleys, public ways, parks, beaches, amusement areas and public buildings; and

WHEREAS, sections 8B-7(2)(e) and (o) of the County Code authorize the County Mayor to limit the movement of persons inside Miami-Dade County in order to safeguard life and health,

THEREFORE, as County Mayor of Miami-Dade County, I hereby order:

1. No group of 10 or more individuals shall gather on a public street, alley, public way, sidewalk, or government facility open to the public in Miami-Dade County.
2. The limitation in paragraph 1 does not apply to: (1) federal, state, or local government employees, or contractors acting on the behalf of such entities, who are providing services in any public street, alley, sidewalk, or public way which require the presence of a group of ten or more individuals, (2) any roadways interior to PortMiami or any airport, (3) individuals traveling by car, bus, truck, train, automated people mover, mass transit, or other powered vehicle, or which waiting at any bus stop, Metromover, or Metrorail station, and (4) individuals responding to an emergency.
3. Essential commercial and retail establishments as defined in Emergency Order 07-20, as amended, should continue to observe the CDC social distancing guidelines, which currently recommends keeping six feet between persons in such establishment. Any commercial or retail establishment which is unable to consistently observe the CDC social distancing guidelines shall be subject to closure by way of subsequent order.
3. Individuals are urged to remain home other than to engage in essential activities which include, without limitation, travel to or from essential retail and commercial businesses as defined in Emergency Order 07-20. Individuals outside their homes shall comply with paragraph 1 of this Order and should attempt to observe the CDC social distancing guidelines.
4. The provisions of this order shall serve as minimum standards. Municipalities may impose more stringent standards within their jurisdictions.
5. This order shall expire upon the expiration of the existing Miami-Dade County State of Local Emergency, except that if such State of Local Emergency is extended, this order shall also be deemed to extend for the duration of such extension. This order may be cancelled earlier by action of the County Mayor.
6. This order shall be effective immediately.
7. This order shall be provided to all appropriate media consistent with the requirements of section 8B-7(2)(n) of the Code of Miami-Dade County.



AMENDMENT NO. 1 TO MIAMI-DADE COUNTY EMERGENCY ORDER 09-20

WHEREAS, on March 21, 2020, the County Mayor issued Emergency Order 09-20; and

WHEREAS, Emergency Order 09-20 directed hotels, motels, and other commercial lodging establishments to stop accepting new reservations from persons other than Essential Lodgers, as defined by the Emergency Order; and

WHEREAS, Emergency Order 09-20 further reduced the occupancy limitations on short-term vacation rentals and directed that new rental agreements for short-term vacation rentals not be on a nightly or weekly basis; and

WHEREAS, Emergency Order 09-20 provided for amendment by filing written notice with the clerk; and

WHEREAS, Miami-Dade County continues to see an influx of travelers and visitors staying in hotels and congregating without observing the social distancing guidelines recommended by the CDC; and

WHEREAS, reports suggest that people are traveling to Florida from areas with severe COVID-19 outbreaks to avoid lockdown orders in their area, which could lead to a further spread of COVID-19; and

WHEREAS, on March 23, 2020, Governor DeSantis issued Executive Order 20-80, which ordered persons flying into Florida from areas with substantial community spread of COVID-19, including the tri-state area New York, New Jersey, and Connecticut, to self-isolate or quarantine for 14 days upon arrival or for the duration of their stay in Florida, whichever is shorter; and

WHEREAS, reducing the influx of potential new carriers will potentially reduce the amount of community spread within Miami-Dade County,

THEREFORE, as County Mayor of Miami-Dade County, I hereby order:

1. Paragraph 1 of Emergency Order 09-20 is hereby amended and restated as follows:

To aid the availability of hotel rooms for (1) healthcare professionals, (2) first responders, (3) National Guard members, (4) law enforcement, (5) state or federal government employees, (6) airline crewmembers, (7) patients, (8) patients' families, (9) journalists, (10) others responding to

COVID-19, (11) displaced residents or visitors, (12) persons unable to return >>to<< their home due to COVID-19 impacts on travel, (13) persons who must vacate their homes due to exigent circumstances, such as fire or flood, (14) persons utilizing hotels as transitional living arrangements, (15) persons sheltering in hotels due to domestic violence, (16) hotel employees, service providers, and contractors, or (17) individuals who, for any reason, are temporarily unable to reside in their home ("Essential Lodgers"), the following restrictions shall apply to commercial lodging establishments:

- (a) Hotels, motels, and other commercial lodging establishments shall not accept new reservations for persons other than Essential Lodgers.
- (b) Hotels, motels, and other commercial lodging establishments may accept reservations for new Essential Lodgers.

>>(c) Commencing March 26, 2020, hotels, motels, short-term vacation rentals, and other commercial lodging establishments shall not (i) accept any occupants, regardless of when reservations were made, or (ii) extend existing reservations, for persons other than Essential Lodgers.<<

2. The balance of Emergency Order 09-20, including provisions related to short-term vacation rentals, remains in full force and effect and is subject to further amendment as set forth in Emergency Order 09-20.

4. Employers are urged to allow any employees who are able to work remotely the ability to do so.
5. The provisions of this order shall serve as minimum standards. Municipalities may impose more stringent standards within their jurisdictions.
6. This order shall be effective immediately.
7. This order shall expire upon the expiration of the existing Miami-Dade County State of Local Emergency, except that if such State of Local Emergency is extended, this order shall also be deemed to extend for the duration of such extension. This order may be cancelled earlier by action of the County Mayor.
8. This order shall be provided to all appropriate media consistent with the requirements of section 8B-7(2)(n) of the Code of Miami-Dade County.

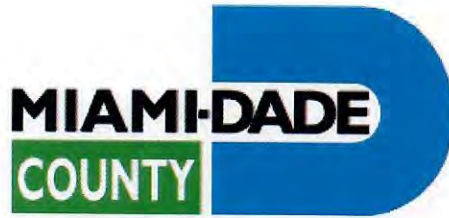

DECLARATION OF LOCAL STATE OF EMERGENCY**

WHEREAS, Section 252.38(3)(a), Florida Statutes, gives authority to political subdivisions to declare and enact a State of Local Emergency for a period of up to seven (7) days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, on March 1, 2020, the Governor of Florida issued Executive Order Number 20-51 directing the State Health Officer and Surgeon General to declare a Public Health Emergency due to the discovery of COVID-19/novel Coronavirus in Florida; and

WHEREAS, on March 9, 2020, the Governor of Florida issued Executive Order Number 20-52, declaring a State of Emergency for the state of Florida related to COVID-19/novel Coronavirus; and

WHEREAS, because COVID-19/novel Coronavirus posed a public health, safety and welfare risk to Miami-Dade County residents, on March 12, 2020, I declared a local state of emergency to respond to the threat posed by the Covid-19/Novel Coronavirus, and to provide for emergency measures to deal with Covid-19/novel Coronavirus remain; and

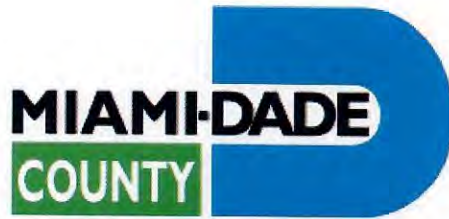

WHEREAS, Emergency Order 07-20, as amended, allows for contractors to provide repair and services to homes and other structures, and allows work to continue on open construction sites; and

WHEREAS, during the past two weeks a number of County employees of the Regulatory and Economic Resources Department who report to or work from the Permitting and Inspection Center located at 11805 SW 26th Street Miami, Florida tested positive for the COVID-19/novel Coronavirus; and

WHEREAS, approximately 400 County employees report to or work from the Permitting and Inspection Center; and

WHEREAS, County building code inspectors almost exclusively report to or work from the Permitting and Inspection Center; and

WHEREAS, the job duties and responsibilities of County building code inspectors is to work out in the public and inspect residential and commercial construction projects to ensure such projects are in compliance with the Florida Building Code; and

WHEREAS, after becoming aware that a number of employees reporting to or working from the Permitting and Inspection Center tested positive for the COVID-19/novel Coronavirus, the Florida Department of Health recommended that the County close the Permitting and Inspection Center and that employees reporting to or working from the Permitting and Inspection Center self-isolate for two weeks; and

WHEREAS, following the recommendations of public health officials, as County Mayor, I closed the Permitting and Inspection Center on March 25, 2020 for a two-week period ending April 7, 2020 and instructed all employees that are based out of the Permitting and Inspection Center to self-isolate for two weeks,

THEREFORE, as County Mayor of Miami-Dade County, I hereby order as follows:

1. All laws, statutes, codes and regulations relating to County employees performing building code functions are suspended, including, but not limited to, the review of plans, issuance of permits, performance of inspections and issuance of certificates of occupancy and completion and temporary certificates of occupancy, and all activities related thereto. I further suspend all laws applicable to the County which are inconsistent with the provisions of this order, including, but not limited to, the requirements to receive and process manually executed plans and the qualifications of personnel to perform building code related services.
2. County employees shall not provide building code inspection services to the public except in accordance with the provisions of this order. To allow for the continuation of construction consistent with the public health, safety and welfare, and in consultation with the Miami-Dade County Building Official, the County hereby adopts the emergency procedures which are attached to this order as Exhibit 1.
3. This order applies to the Unincorporated Municipal Services Area (UMSA) of Miami-Dade County and all other areas within municipalities under the jurisdiction of the Miami-Dade County Building Official. This order does not and is not intended to bind municipal Building Officials' performance of building code related services within the areas of their jurisdiction.
4. This order shall expire upon the expiration of the existing Miami-Dade County State of Local Emergency, except that if such State of Local Emergency is extended, this order shall also be deemed to extend for the duration of such extension. This order may be cancelled earlier by action of the County Mayor.

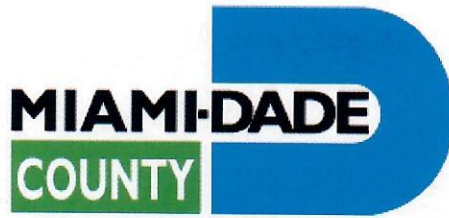
PROCEDURES FOR BUILDING CODE INSPECTIONS DURING COVID-19 Emergency Period

These are the procedures for Building Code inspections to be used during the Department of Regulatory and Economic Resources' (RER) suspension of Building trades inspection services due to the COVID-19 Emergency Period (the "COVID-19 Emergency"). This suspension of inspection services is effective immediately and shall be in effect until further notice to be given upon expiration of the County Mayor's Emergency Order governing these services. This notice does not set forth procedures for Fire Code inspections. RER shall issue a separate notice governing Building Code permitting procedures during the COVID-19 Emergency.

1. Inspections may be performed by a State of Florida licensed and registered architect or engineer who has no financial interest in the construction. Inspections by TAS301 accredited laboratories are also acceptable provided they are signed and sealed by the qualified independent professional. This procedure does not supersede or otherwise limit other inspection procedures currently allotted to threshold and special inspectors.
2. Under the authority of Executive Order Number 20-52 Emergency Management COVID-19, RER will allow certain inspections to be performed by State of Florida or Miami-Dade County licensed contractors certified under the category of work performed (see No. 5 below). The contractor cannot be the permit holder and or have any financial interest in the construction.
3. Final inspections must be performed by Miami-Dade County once inspection services resume. For projects that are pending only final inspections, RER will consider issuing a Temporary Certificate of Occupancy (TCO) on a case by case basis. All previous inspections must have been performed by the County and have only a final pending. The applicant must complete the [TCO form](#) and submit to RER-SPA@miamidade.gov for review. If approved, the TCO will be issued for a period of no more than 30 calendar days, unless otherwise extended by the Building Official.
4. Inspections must be reported on the RER STATEMENT OF INSPECTION REPORT COVID-19. A Report must be completed per permit. The individual providing the statement must perform and record all inspections for the permit number and provide the completed report to Miami-Dade County via the email addresses below for the respective trade supervisor or to the RER inspector at the next scheduled inspection.

5. For residential properties (single family, duplex and townhouses), inspections for the following permit types and categories can be performed by State of Florida or Miami-Dade County licensed contractors certified under the category of work performed, so long as such contractors are not the permit holder or have any financial interest in the construction.
 - a. Residential Building permit, (permit category 02) for alterations, repairs and additions under 1000 square feet, roofing, accessory structures such as pool, fence and sheds and other miscellaneous permits such as metal awnings, shutters.
 - b. Mechanical work associated with master permit or any mechanical standalone permits for Air conditioning (03), Heating (10), Insulation (11), Air conditioning Duct Work (23) and Ventilation (41).
 - c. Plumbing work associated with the master permit or any plumbing standalone permits under general plumbing (01), Lawn Sprinkler (03), Solar Water Heater (07), Pool Piping (10), Pool Maintenance (09), and Pool Service (12).
 - d. Electrical Work associated with the master permit or electrical standalone permits under General Electric (01), Swimming Pools (23), change out of exact replacement of A/C (31) and Solar Photovoltaic (34).
6. Compliance with the provisions for inspections above shall be presumed to satisfy Florida Building Code requirements for the performance of building inspections.
7. RER encourages the use of photographs or other documentation that supports the inspection result and can be attached to the report.



MIAMI-DADE COUNTY EMERGENCY ORDER 15-20

WHEREAS, section 252.38(3)(a), Florida Statutes, gives political subdivisions the authority to declare and enact a State of Local Emergency for a period of up to seven days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, on March 1, 2020, the Governor of Florida issued Executive Order Number 20-51, directing the State Health Officer and Surgeon General to declare a Public Health Emergency due to the discovery of COVID-19/novel Coronavirus in Florida; and

WHEREAS, on March 9, 2020, the Governor of Florida issued Executive Order Number 20-52, declaring a State of Emergency for the State of Florida related to COVID-19/novel Coronavirus; and

WHEREAS, on March 12, 2020, the County Mayor declared a State of Emergency for all of Miami-Dade County; and

WHEREAS, COVID-19/novel Coronavirus poses a health risk to Miami-Dade County residents, particularly elderly residents and those who are immunosuppressed or otherwise have high-risk medical conditions; and

WHEREAS, minimization of social contact is necessary to avoid risk of COVID-19 infection for the residents of the County; and

WHEREAS, the federal government is urging persons throughout the United States to continue practicing social distancing through April 30, 2020, as recommended by the United States Centers for Disease Control and Prevention guidelines; and

WHEREAS, persons are currently congregating in such pool, fitness areas, and other common amenities of hotels, condominiums, and other developments and are using empty golf courses to congregate in lieu of parks,

THEREFORE, as County Mayor of Miami-Dade County, I hereby order:

1. All pools, hot tubs, golf courses, tennis courts, basketball courts, fitness centers, gymnasiums and other common use amenities, whether of a commercial or non-commercial nature, are closed for all purposes. Notwithstanding the foregoing, this order does not apply to any pool, hot tub, tennis court, basketball court, fitness center, gymnasium or other amenity located: (a) on a single family residential lot, or, (b) at any townhouse, duplex, or villa, and

which is for the exclusive recreational or leisure use of the inhabitants of such individual dwelling unit.

2. This order supersedes Emergency Orders 03-20, 06-20, and 09-20 to the extent inconsistent herewith.
3. This order shall be effective immediately.
4. This order shall expire upon the expiration of the existing Miami-Dade County State of Local Emergency, except that if such State of Local Emergency is extended, this order shall also be deemed to extend for the duration of such extension. This order may be cancelled earlier by action of the County Mayor.
5. This order shall be provided to all appropriate media consistent with the requirements of section 8B-7(2)(n) of the Code of Miami-Dade County.
