Subject: Request for Additional Expenditure Authority to Contract SS9737-1/23-1, Cellebrite

Forensic System, Service and Maintenance Resolution No. R-637-20

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize additional expenditure authority to *Contract No. SS9737-1/23-1*, *Cellebrite Forensic System, Service and Maintenance*, for the Miami-Dade Police Department. The Police Department is requesting \$283,000 in additional expenditure authority to purchase additional software and hardware licenses needed to assist with investigating crimes.

This sole source contract was awarded under delegated authority to Cellebrite, Inc. in March 2013 for an initial five-year term with one, five-year option to renew term. The five-year option to renew term was presented to the Board as a designated purchase and was adopted by the Board.

The contract provides maintenance and support services required for the Uniform Forensic Extraction System used by the Police Department. Additional expenditure authority is requested to purchase new software and hardware licenses, which are critical to the investigation process and will allow for clearer case analysis to potentially solve crimes.

Scope

The impact of this item is countywide in nature.

Fiscal Impact/Funding Source

The contract expires on April 30, 2023 and has a current cumulative allocation of \$338,000. If this request is approved, the contract will have a modified cumulative allocation of \$621,000. The requested allocation is based on additional software and hardware licenses needed.

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board authorizes additional expenditure authority in an amount up to \$283,000.00 for a modified total contract award of \$621,000.00 for Contract No. SS9737-1/23-1 for the purchase of Cellebrite Forensic System, Service and Maintenance for the Miami-Dade Police Department.

Section 2. This Board authorizes the County Mayor or County Mayor's designee to exercise all provisions of Contract No. SS9737-1/23-1, including any extensions or cancellations, pursuant to Section 2-8.1 of the Code of Miami-Dade County, Florida and Implementing Order 3-38. A copy of the contract document is on file with and available upon request from the Internal Services Department, Strategic Procurement Division.
