RESOLUTION NO. _____ R-591-20

RESOLUTION EXPRESSING SHOCK AND CONDOLENCES AT THE DEATH OF GEORGE FLOYD; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO SUBMIT A REPORT THAT DESCRIBES THE MIAMI-DADE POLICE DEPARTMENT'S PRACTICES, POLICIES, AND PROCEDURES RELATED TO ARRESTS, CUSTODY, PHYSICAL RESTRAINT, AND USE OF FORCE; AND DIRECTING THAT THE REPORT BE PLACED ON AN AGENDA OF THE FULL BOARD WITHOUT COMMITTEE REVIEW

WHEREAS, on May 25, 2020, George Floyd, a 46-year old African-American man, died in Minneapolis, Minnesota while in custody of the Minneapolis Police Department; and

WHEREAS, although handcuffed and lying face down on the road, a Minneapolis police officer knelt on Mr. Floyd's neck for over eight minutes; and

WHEREAS, for over two of those minutes, Mr. Floyd was unresponsive, and three other police officers who either held Mr. Floyd's legs or stood nearby did not intervene; and

WHEREAS, video recordings of Mr. Floyd's arrest and subsequent death show Mr. Floyd moaning and sobbing while saying "please," "I can't breathe," "I'm about to die," and "don't kill me;" and

WHEREAS, all four officers were fired on May 26, 2020; and

WHEREAS, on May 29, 2020, the officer who held his knee on Mr. Floyd's neck was arrested and charged with third-degree murder and manslaughter; and

WHEREAS, the prosecutor also stated that he anticipated charges would be brought against the other three officers who were at the scene of Mr. Floyd's death; and

WHEREAS, additionally, the Minneapolis Police Department requested that the Federal Bureau of Investigation conduct a federal civil rights investigation into Mr. Floyd's death; and

WHEREAS, the Minnesota Bureau of Criminal Apprehension is also investigating possible violations of Minnesota state law in relation to Mr. Floyd's death; and

WHEREAS, the day after Mr. Floyd's death, protests began in the Minneapolis area; and

WHEREAS, since that time, similar protests have erupted across the country in cities that include Miami, Atlanta, New York, Washington, D.C., and Dallas; and

WHEREAS, some of the above-mentioned protests have been peaceful, but riots involving fires, looting, vandalism, and other property damage and destruction evolved at others; and

WHEREAS, the Miami-Dade Police Department ("MDPD") is an exemplary agency with well-trained and qualified police officers and civilian personnel; and

WHEREAS, nonetheless, police departments across the nation are under increased scrutiny for the deaths of unarmed Black men and boys at the hands of officers who have been entrusted to serve and protect the community; and

WHEREAS, in an effort to reassure the residents of and visitors to Miami-Dade County that the MDPD has taken all reasonable and necessary steps to train its officers to protect the community and themselves in a manner that does not unnecessarily risk lives, this Board directs the County Mayor or County Mayor's designee to provide a report pertaining to the practices, policies, and procedures for MDPD officers,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Expresses shock and condolences at the death of George Floyd.

Section 2. Directs the County Mayor or County Mayor’s designee to prepare and submit a report that includes Miami-Dade Police Department’s practices, policies, and procedures related to arrests, custody, physical restraint, and use of force.

Section 3. Directs the County Mayor or County Mayor’s designee to provide the report to this Board within 30 days of the effective date of this resolution and to place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.

Section 4. Directs that the report, upon completion, be placed directly on an agenda of the full Board without committee review.

Section 5. Directs the Clerk of the Board to transmit a certified copy of this resolution to the family of George Floyd.

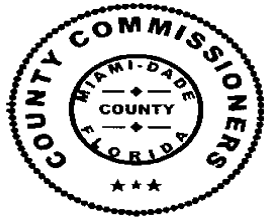
