RESOLUTION NO. R-1022-20

RESOLUTION RATIFYING THE REAPPOINTMENT OF MARC DOUTHIT AND BARBARA MONTERO AS MEMBERS OF THE MIAMI-DADE ECONOMIC ADVOCACY TRUST'S NOMINATING COUNCIL ("NOMINATING COUNCIL") FOR A TERM OF THREE YEARS EACH BY THE CHAIRPERSON OF THE BOARD; WAIVING TERM LIMIT RESTRICTION BY A TWO-THIRDS VOTE OF THE FULL MEMBERSHIP OF THE BOARD AND RATIFYING APPOINTMENT OF SHELDON EDWARDS AS A MEMBER OF THE NOMINATING COUNCIL FOR A THREE YEAR TERM BY THE CHAIRPERSON OF THE BOARD

WHEREAS, the Miami-Dade Board of County Commissioners (the "Board") established the Miami-Dade Economic Advocacy Trust (the "Trust") to ensure for the equitable participation of Blacks in Miami-Dade County's economic growth through advocacy and monitoring of economic conditions and economic development initiatives in Miami-Dade County; and

WHEREAS, the Trust has a board of trustees (the "Board of Trustees"), which is composed of 15 voting members; and

WHEREAS, this Board established a nominating council (the "Nominating Council") for

the Trust, which is comprised of the following five members: (1) the chairperson of the Trust, (2)

the Chairperson of the Board's committee with jurisdiction over economic development, and (3)

three members appointed by the Board's Chairperson, subject to ratification by the Board; and

WHEREAS, the sole function of the Nominating Council is to solicit, screen, interview and recommend for appointment by this Board the best qualified candidate for each vacancy of the Board of Trustees; and **WHEREAS**, on June 21, 2016, this Board adopted Resolution No. R-577-16, which ratified the Chairperson of the Board's appointment of Marc Douthit, Esq. and Barbara Montero as members of the Nominating Council; and

WHEREAS, the Chairperson of this Board has reappointed Mr. Douthit and Mrs. Montero to the Nominating Council, each for an additional three-year term, and seeks this Board's ratification of such reappointments; and

WHEREAS, Mr. Douthit, whose resume is attached hereto as Exhibit "A" and incorporated herein by reference, is an attorney in good standing with the Florida Bar; and

WHEREAS, Mr. Douthit previously served as a member of the Trust from 2009 to 2014, and during his term he also served as chairperson of the Trust; and

WHEREAS, Mrs. Montero, whose resume is attached hereto as Exhibit "B" and incorporated herein by reference, is, among other things, the founder and a board member of SafetyPay, a privately held, venture capital backed, global Internet payment systems company; and

WHEREAS, Mrs. Montero previously served as a member of the Trust from 2009 to 2014; and

WHEREAS, the Chairperson of this Board also desires to appoint Sheldon Edwards, whose resume is attached hereto as Exhibit "C" and incorporated herein by reference, to the Nominating Council; and

WHEREAS, Mr. Edwards currently serves as a minority and small business enterprise manager at Miami Dade College; and

WHEREAS, Mr. Edwards previously served as a member of the Trust from 2014 to 2020, and during his term he also served as chairperson of the Trust; and

WHEREAS, in order for this Board to ratify the Chairperson's appointment of Mr. Edwards, who served two consecutive terms on the Trust, to the Nominating Council, this Board, in accordance with section 2-503(a) and (d) of the Code of Miami-Dade County (the "Code"), must waive by a two-thirds vote of the full membership of the Board the term limit restriction set forth therein; and

WHEREAS, accordingly, this Board desires to waive said term limit restriction; and

WHEREAS, this Board has reviewed the resumes or biographical information of each of Mr. Douthit, Mrs. Montero, and Mr. Edwards, is satisfied that they meet or exceed the minimum qualifications to serve as members of the Nominating Council, and desires to ratify the reappointment of Mr. Douthit and Mrs. Montero and the appointment of Mr. Edwards to the Nominating Council,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONS OF MIAMI-DADE COUNTY, FLORIDA, that:

<u>Section 1</u>. The matters contained in the foregoing recitals are incorporated in this resolution by reference.

<u>Section 2</u>. This Board hereby ratifies the reappointment of Marc Douthit, Esq. and Barbara Montero to serve as members of the Miami-Dade Economic Advocacy Trust's Nominating Council by the Chairperson of the Board in accordance with section 2-503 of the Code. Mr. Douthit and Mrs. Montero shall each serve a term of three years.

Section 3. This Board hereby waives the term limit restriction set forth in section 2-503(a) and (d) of the Code by a two-thirds vote of the full membership of the Board and ratifies appointment of Sheldon Edwards to the Nominating Council by the Chairperson of the Board in accordance with the Code. Mr. Edwards shall serve a term of three years.
