RESOLUTION APPROVING THE CITY OF SWEETWATER'S CODESIGNATION OF THAT PORTION OF NORTHWEST 112TH AVENUE FROM SOUTHWEST 7TH TERRACE TO NORTHWEST 7TH STREET AND THAT PORTION OF NORTHWEST 111TH AVENUE AND NORTHWEST 112TH AVENUE FROM NORTHWEST 12TH STREET NORTHWEST 25TH STREET AS "SWEETWATER BOULEVARD"

WHEREAS, on June 6, 2022, the City Commission of the City of Sweetwater passed Resolution No. 4837, which codesignated that portion of Northwest 112th Avenue from Southwest 7th Terrace to Northwest 7th Street and that portion of Northwest 111th Avenue and Northwest 112th Avenue from Northwest 12th Street to Northwest 25th Street as "Sweetwater Boulevard"; and

**WHEREAS**, a copy of Resolution No. 4837 is attached hereto and incorporated by reference; and

**WHEREAS**, many municipalities within Miami-Dade County have a designated street within their municipal limits that is named after the respective municipality; and

WHEREAS, through this codesignation, the City of Sweetwater has now designated the longest street within its municipal limits as its principal street, which the City believes will further the marketability of the City of Sweetwater and allow visitors to better acknowledge that they are within the municipal limits of the City of Sweetwater; and

WHEREAS, the City of Sweetwater would like the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this Board would like to support the City of Sweetwater by approving the City of Sweetwater's codesignation of that portion of Northwest 112th Avenue from Southwest 7th Terrace to Northwest 7th Street and that portion of Northwest 111th Avenue and Northwest 112th Avenue from Northwest 12th Street to Northwest 25th Street as "Sweetwater Boulevard"; and

WHEREAS, that portion of Northwest 112th Avenue from Southwest 7th Terrace to Northwest 7th Street and that portion of Northwest 111th Avenue and Northwest 112th Avenue from Northwest 12th Street to Northwest 25th Street is a city-maintained road located in the City of Sweetwater; and

WHEREAS, this codesignation is located in County Commission District 12,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Sweetwater's codesignation of that portion of Northwest 112th Avenue from Southwest 7th Terrace to Northwest 7th Street and that portion of Northwest 111th Avenue and Northwest 112th Avenue from Northwest 12th Street to Northwest 25th Street as "Sweetwater Boulevard".

Section 2. Directs the Clerk of the Board to transmit certified copies of this Resolution to the Mayor and City Commission of the City of Sweetwater, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Fire Rescue Department, and the City of Sweetwater Police Department.

Resolution 4837

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SWEETWATER DESIGNATING PORTIONS OF 111<sup>TH</sup> AND 112<sup>TH</sup> AVENUE AS "SWEETWATER BOULEVARD", PROVIDING FOR TRANSMITTAL; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, many municipalities throughout Miami-Dade County have a designated street within their municipal limits named after the respective municipality; and

**WHEREAS**, the portion of 112<sup>th</sup> Avenue from Southwest Seventh Terrace to Northwest Seventh Street and 111<sup>th</sup> Avenue and 112<sup>th</sup> Avenue from Northwest Twelfth Street to Northwest 25<sup>th</sup> Street shall (the "Street") is a City-maintained street located in the City of Sweetwater; and

WHEREAS, the Street is the longest street within City limits, making it best to become a principal street; and,

WHEREAS, designating the Street as "Sweetwater Boulevard" would allow for further marketability of the City and for visitors to acknowledge that they are within City limits;

**NOW THEREFORE**, be it resolved by the City Commission of the City of Sweetwater:

- 1. The foregoing preamble is incorporated herein by reference as if set forth in full.
- 2. The portion of 112<sup>th</sup> Avenue from Southwest Seventh Terrace to Northwest Seventh Street and 111<sup>th</sup> Avenue and 112<sup>th</sup> Avenue from Northwest Twelfth Street to Northwest 25<sup>th</sup> Street shall, as soon as authorized by Miami-Dade County, be co-designated as "Sweetwater Boulevard". Signage on traffic signals may designate The Street as "Sweetwater Blvd".
- 3. The City Clerk and City Engineer are hereby directed to submit this Resolution to the appropriate departments within Miami-Dade County and to take all other actions necessary to carry out the purpose of this Resolution.
- 4. This resolution shall become effective upon its adoption by the City Commission and approval by the Mayor or if vetoed, upon its reenactment by the City Commission as provided by the Charter of the City of Sweetwater.
