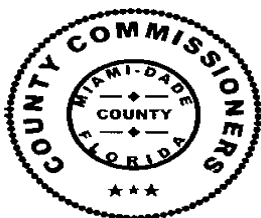
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
