RESOLUTION WAIVING REQUIREMENTS OF
IMPLEMENTING ORDER 3-38 FOR SECURING
SPONSORSHIP AND PURCHASING OF GOODS AND
SERVICES FOR HOSTING THE 16TH ANNUAL MIAMI
INTERNATIONAL AGRICULTURE, HORSE AND CATTLE
SHOW TO BE HELD FROM APRIL 14-16, 2023

WHEREAS, the 16th annual Miami International Agriculture, Horse and Cattle Show (“MIAHCS”)-an important County event the County desires to continue to hold in the future-is scheduled to take place at Tropical Park from April 14-16, 2023; and

WHEREAS, in order to ensure the success of the 16th annual MIAHCS, the County desires to purchase certain goods and services (some of which are highly specialized and technical insofar as they relate to agriculture, horses, and cattle) utilizing budgeted MIAHCS funds approved by this Board; and

WHEREAS, in addition to the foregoing, the Office of County Commissioner Javier D. Souto desires to secure sponsors to assist in defraying the costs of this County event; and

WHEREAS, Implementing Order 3-38 was established pursuant to section 2-8.1 of the Code of Miami-Dade County to establish, whenever possible, competitive processes and procedures for the County’s purchase of goods and services; and

WHEREAS, while the dollar value of the goods, services, and sponsorships sought to be secured for the 16th annual MIAHCS is below the threshold amount requiring formal sealed bids under County regulations, those County regulations nevertheless require market researched and written quotes in advance of such purchase; and

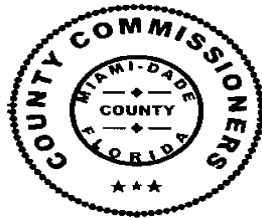
WHEREAS, due to the nature of the goods, services, and sponsorships that the County desires to obtain, and to ensure that the 16th annual MIAHCS goes forward with the same success as in years past, it is in the best interest of the County to waive the requirements of Implementing Order 3-38,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the requirements of Implementing Order 3-38 are waived for the purposes of obtaining sponsorships and purchasing goods and services to host the 16th annual MIAHCS on April 14 through 16, 2023.

The Prime Sponsor of the foregoing resolution is Senator Javier D. Souto. It was offered by Commissioner **José "Pepe" Diaz** , who moved its adoption. The motion was seconded by Commissioner **Raquel A. Regalado** and upon being put to a vote, the vote was as follows:
