(Crystal Academy Therapy Center and School) \$100,000.00,

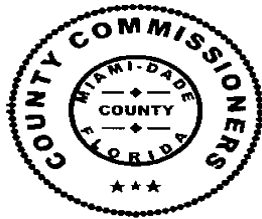
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
