

SUBJECT: Agenda Item No. (2F) Resolution urging the U.S. Congress to amend federal law related to medical benefits for incarcerated individuals

Due to a scheduling conflict, I cannot attend the April 10, 2007 Budget and Finance Committee meeting. I am respectfully requesting that the committee consider my resolution, urging the U.S. Congress to amend federal law to allow federal financial participation in providing medical benefits to incarcerated individuals until convicted and sentenced to secure detention, with a favorable recommendation.

I would like to bring to your attention a County Manager report regarding Inmate Healthcare Services that is listed on the April 12, 2007 Health and Public Safety Committee agenda. As stated within the report, **Jackson Health System provides approximately \$24 million in medical services to inmates** through a contract between Miami-Dade Corrections and Rehabilitative Department and the Public Health Trust.




