Mr. Jack Kardys, Director, Park & Recreation Department (MDPR), gave a status report regarding the upcoming Miami International Agriculture & Cattle Show (MIACS). He noted the show would be held on March 20th, 21st and 22nd at the Ronald Regan Equestrian Center in Tropical Park. Mr. Kardys said currently 380 heads of cattle were registered to participate in this year's show. More than 50 ranches from ten states would be featured in the show, noted Mr. Kardys. He also noted that the show had been expanded to include the Homestead Plant Expo; 60 nurseries, retail and wholesale operations would participate in the cattle show selling their products. Mr. Kardys said the public education classes would focus on treatment of pests that plague agriculture. He noted that advertisements had been placed on buses, and posters had been placed throughout Miami-Dade County. Mr. Kardys pointed out the most impressive part was the number of sponsorships that appeared on the advertisement posters.

Chairman Souto requested to meet with the Miami-Dade Aviation Director, the Seaport Director, and out-of-town visitors who were also representatives of the cattle industry on March 19 and March 20, 2009 to discuss the export of animals.

Ms. Ana Sotorrio, Associate Aviation Director, Miami-Dade Aviation Department, suggested that representatives of the United States Department of Agriculture be involved in the discussions.

Chairman Souto concurred with Ms. Sotorrio's suggestion.

Chairman Souto expressed appreciation to the committee members and Mr. Kardys for their continued support of the MIACS.

He noted the contractor and CAD staff worked closely to address all of the pending problems with the building. Mr. Spring pointed out that the curtain wall would be replaced rather than repaired and other building issues were being repaired. He said he was confident that the contractor was committed to addressing the existing problems with the building.*

Report: *Mr. Bill Talbert, President/Chief Executive Officer, Greater Miami Convention and Visitors Bureau (GMCVB), provided an update regarding travel and tourism activity. Mr. Talbert apprised the Committee that advertisements for the 2nd Annual Miami International Agriculture & Cattle Show were featured within the GMCVBs weekly newsletter for the last six months. He said Tiger Woods would be competing in the World Golf Championship in Doral March 9th through March 15th and the World Baseball Classic would be held at Dolphin Stadium March 14th through 18th. Mr. Talbert said media coverage would be provided for both events and these events would attract many tourists to Miami-Dade County.*

Mr. Talbert noted the February tourism report was similar to January's report—in February Miami ranked number two in hotel occupancy and Miami was number two in room rates. He stated that seven of the top 25 destinations had decreased by double digits in room rates. Mr. Talbert estimated that Tourism Development Tax (TDT) revenue collections were down approximately 16% for the balance of the fiscal year. He said during the preparation of the budget he would review the TDT collections and hotel bookings for this year and compose the budget according to the numbers reflected. Mr. Talbert pointed out that Brazil was the number one feeder market in terms of expenditures. He noted although this year's South Beach Wine & Food Festival's sponsorships were down, this event set a record for high ticket sales. Mr. Talbert also noted the International POW WOW would be held May 16th through 20th. He said the 2008 Visitor Profile would be prepared within two weeks and he would distribute this data to all Committee members.

Report: *Ms. Hydi Webb, Director of Cruise Development, Port of Miami (Seaport), gave a brief report regarding travel activity at the Seaport. Ms. Webb said last fiscal year the Seaport posted over 4.1 million passengers which was a record number of passengers. She said the figures for January were positive as well; and the passenger count for January 2009 was 421,629, compared to 394,467 in January 2008. Ms. Webb noted this represented a 7% increase from last January's figures. She said to date the Seaport had welcomed over 1.5 million cruise passengers which represented a year to date increase of 8% over last fiscal year. Ms. Webb noted last year's passenger revenue totaled 39.5 million dollars; and as of January 2009, passenger revenue totaled 15.5 million dollars, 10% above last year's figures.*

Chairman Souto asked the Miami-Dade Aviation Department Director and the Seaport Director to expedite efforts to ensure that the 2009 Miami International Agriculture & Cattle Show was promoted and advertised throughout the Airport and the Seaport.

Ms. Ana Sotorrio, Associate Aviation Director, Miami-Dade Aviation Department (MDAD), gave a brief report regarding travel activity at the Miami International Airport (MIA). Ms. Sotorrio said traffic performance was up approximately 1%, and that MIA had outperformed other airports in the nation which had experienced severe declines. She noted during January domestic travel declined approximately one and a half percent, but international traffic rose 1.2%, and she expected that February would be the same. Ms. Sotorrio said declines were steep on the cargo side of operations as well. Ms. Sotorrio said the advertisements for the Miami International Agriculture & Cattle Show were being installed throughout MIA this week.

In response to Commissioner Jordan's inquiry regarding declining domestic passengers at MIA versus Broward's Airport and whether this was

Report: *Commissioner Heyman requested continued funding for the film industry in Miami-Dade County (MDC), and for the annual "Love In" event. She noted this event was the only event held in the north area of MDC. Commissioner Heyman spoke in support of the Agriculture and Cattle Show and the Rib Fest. She noted she supported the efforts of Park and Recreation Department Director Jack Kardys to continuously promote public/ private partnerships.*

With regard to the proposed FY 2009-2010 budget Mr. Daniel Alfonso, Budget Coordinator, Office of Strategic Business Management (OSBM), noted that he and staff were currently meeting with departments regarding expenditures and revenues. He said they were trying to ascertain from an expenditure point of view, the amount of funding it would take to fund the same level of services in the current year for next year. Mr. Alfonso said he asked departments to inform him of the areas they would like to improve as well as the areas they would propose as reductions if the need arose. He said he was asking departments to look at their revenues and determine whether all projections were prudent, and he was trying to ascertain the amount of general funds. Mr. Alfonso pointed out there would be a significant gap between the revenues received and the expenditures needed to maintain the same level of services. He noted he anticipated the gap next year to be larger than the gap last year. Mr. Alfonso said the gap depended upon the property tax roll and the millage adopted by the Board of County Commissioners.

In response to Commissioner Sorenson's suggestion of hiring people part time as opposed to allowing overtime to current employees, Mr. Kardys said that department directors were looking for that type of efficiency and that hiring part time people at large events was a feasible option.

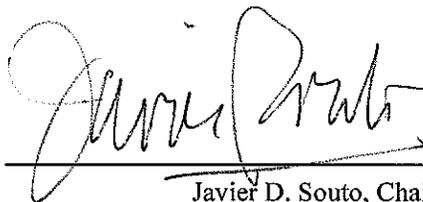

Arsht Center for the Performing Arts (PAC), noted that the PAC was currently on target with its attendance levels. He said that next year 500 events were included within the budget, 25 more events than this current year, which represented a 5% increase. Mr. Richards said the PAC was planning to present "The Arsht Center Presents" 219 of it own events. He noted the other events were through resident companies and rentals to other organizations and commercial entities. Mr. Richards said an opportunity existed to be commercially thoughtful in the rental of the facilities, present great art to the community as well as provide free events to the community. He noted the PAC would celebrate its one millionth patron during the month of April. Mr. Richards said attendance at the PAC had grown as a result of the quality of the presentations, noting that the Cleveland Orchestra had a sold out show, Marcello Giordani was nearly sold out as well, and the Dallas Symphony Orchestra with Pinchas Zuckerman, Tenor Jose Carreras, and Kodo Drums were all outstanding upcoming shows. 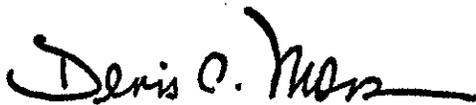
