

092764 ORDINANCE CREATING AND ESTABLISHING OFFICE OF COMMUNITY AFFAIRS UNDER THE BOARD OF COUNTY COMMISSIONERS TO PROVIDE SUPPORT TO THE COMMUNITY RELATIONS BOARD, THE MIAMI-DADE COUNTY HISPANIC AFFAIRS ADVISORY BOARD, THE MIAMI-DADE COUNTY BLACK AFFAIRS ADVISORY BOARD, THE MIAMI-DADE COUNTY ASIAN-AMERICAN ADVISORY BOARD, THE MIAMI-DADE COUNTY COMMISSION ON HUMAN RIGHTS, AND THE COMMISSION FOR WOMEN; AMENDING SECTIONS 2-207, 2-535, 2-835, 2-1090, CHAPTER 11A, AND ARTICLE XXX OF CHAPTER 2 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA, RELATING TO THE COMMUNITY RELATIONS BOARD, THE MIAMI-DADE COUNTY HISPANIC AFFAIRS ADVISORY BOARD, THE MIAMI-DADE COUNTY BLACK AFFAIRS ADVISORY BOARD, THE MIAMI-DADE COUNTY ASIAN-AMERICAN ADVISORY BOARD, THE MIAMI-DADE COUNTY COMMISSION ON HUMAN RIGHTS, AND THE COMMISSION FOR WOMEN, RESPECTIVELY, TO PROVIDE THAT THE OFFICE OF COMMUNITY AFFAIRS, RATHER THAN THE COUNTY MAYOR AND COUNTY MANAGER, SHALL PROVIDE SUPPORT FOR SUCH ADVISORY BOARDS; AMENDING THE FISCAL YEAR 2009-10 COUNTY BUDGET; REMOVING APPROPRIATED FUNDING, REVENUE AND POSITIONS FROM THE OFFICE OF COMMUNITY ADVOCACY; APPROPRIATING FUNDING, REVENUE AND POSITIONS TO THE OFFICE OF COMMUNITY AFFAIRS UNDER THE BOARD OF COUNTY COMMISSIONERS; RESCINDING ADMINISTRATIVE ORDER NO. 9-2 RELATING TO THE OFFICE OF COMMUNITY RELATIONS; APPROPRIATING GRANT FUNDS; PROVIDING SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE


