CDMP on April 18, 2012

I will be unable to attend the April 18, 2012 Comprehensive Development Master Plan meeting of the Board of County Commissioners. This is the final meeting for an application in my district by Blanca Castro – application 1 on the agenda.

I had raised two concerns at the initial hearing – first, that the Community Council 8 had not had an opportunity to weigh in on this item. Second, the applicant had attempted to provide a covenant restricting the uses allowed on the property but those restrictions did not meet legal sufficiency. Since that time, the Community Council heard and recommended approval of the item, and staff has worked with the applicant to provide a legal covenant.

For those reasons, I am in support of this item.
