## **Human and Social Services Community-Based Organization (CBO) Funding Request for Proposal (RFP) to be released May 27, 2010**

**(Miami-Dade County, FL)** -- Miami-Dade County is soliciting proposals to disburse County General Funds for human and social services for County residents. Eligibility to apply for this funding is limited to 501(c)(3) not-for-profit organizations, including churches.

Private (not-for-profit) providers and/or faith-based providers are needed to provide services in the following Service Priority Areas: 1) Basic Needs; 2) Children and Adults with Disabilities; 3) Children, Youth, and Families; 4) Criminal Justice; 5) Elder Needs; 6) Health; 7) Immigrants/New Entrants; 8) Other, including parks programming and community economic development; 9) Special Needs; and 10) Workforce Development.
