Dear Ryan White Program-funded Subrecipients, Clients, and Other Stakeholders:

RE: Revised Ryan White Program Oral Health Care Formulary – Fiscal Year 2023

Attached for your information is a summary list of covered Oral Health Care procedures for Miami-Dade County's Ryan White Part A Program for Fiscal Year (FY) 2023. Please see attached.

Due to copyright limitations, the more detailed version of the local Oral Health Care Formulary, with codes and descriptors, is only being distributed to licensed users of Provide[®] Enterprise Miami under Oral Health Care and Medical Case Management. Only the version sorted by code will be provided to them.

As a reminder, Ryan White Program Oral Health Care services are available to eligible HIV+ clients who have a gross household income that does not exceed 400% of the Federal Poverty Level Guidelines, and who reside in Miami-Dade County. The Ryan White Program must be the payer of last resort.

Here is a summary of some important changes:

- Effective March 1, 2023:
 - o Dental Implants were added to the list of available procedures:
 - 10 related codes were added.
 - These procedures are limited in number and who can access the benefit.
 - Dental implants under this program are not for cosmetic purposes.
 - A Letter of Medical Necessity for Dental Implants is required. See attached.
 - Removable Unilateral Partial Denture was added.
 - Tele-Dentistry codes were added. They were missing from the previous version of the formulary.
- Effective July 1, 2023:
 - The annual cap limitation on services of \$6,500 per client per year has been discontinued.
 - Reimbursement rates for Ryan White Part A Program-allowable dental procedures underwent an internal review and rate analysis. As a result, reimbursement rates increased effective July 1, 2023.
