NOTICE OF PUBLIC HEARING ON PROPOSED FY 2017 ACTION PLAN FUNDING RECOMMENDATIONS, SUBSTANTIAL AMENDMENTS TO FY 2009-2016 ACTION PLANS, AND CORRESPONDING FY 2008-2012 AND FY 2013-17 CONSOLIDATED PLANS OF THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME) FUNDS, AND EMERGENCY SOLUTIONS GRANT (ESG) PROGRAM

The **Housing and Social Services Committee (HSSC)** will hold a **public hearing** on **Monday, July 10th, 2017 at 9:30 a.m.**, or the next regularly scheduled HSSC meeting if not approved, due to lack of quorum or deferral. The item will be considered for final action at the **Board of County Commissioners (BCC) Meeting on Tuesday, July 18th, 2017 at 9:30 a.m.**, or the next regularly scheduled BCC Meeting if not approved due to deferral. Both meetings will be held inside Board of County Commission Chambers located on the second level of the Stephen P. Clark Center, 111 NW 1st Street, Miami, Florida 33128. The purpose of the hearing is to give the **public an opportunity to comment** on the proposed FY 2017 Action Plan Funding Recommendations, Substantial Amendments to the FY 2009-2016 Action Plans, and corresponding FY 2008-12 and FY 2013-17 Consolidated Plans.

The Proposed FY 2017 Action Plan includes the following funding sources:

- **CDBG:** up to \$11,553,854.00 allocated to public service, economic development, public facilities and capital improvements, housing, and administration.
- **HOME:** up to \$1,400,086.00 allocated to rental housing rehabilitation, homeownership rehabilitation, homeless housing, tenant-based rental assistance, and administration.
- **ESG:** up to \$1,005,743.00 allocated for emergency shelter and outreach, homeless prevention and rapid rehousing, and administration.

The Substantial Amendments to the FY 2009-2016 Action Plans, and Corresponding FY 2008-12 and FY 2013-17 Consolidated Plans includes the following sources:

- **CDBG Recapture and Reallocation Amount:** up to \$719,656.69
- **HOME Recapture and Reallocation Amount:** up to \$745,092.36

Items Recommended for Approval include the following:

- Approve the FY 2017 Action Plan, which includes an annual update to the corresponding FY 2013-2017 Consolidated Plan, and the FY 2017 funding recommendations for the Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) Program funds
- Approve submission of substantial amendment Substantial Amendments to FY 2009-2016 Action Plans, and Corresponding FY 2008-2012 And FY 2013-17 Consolidated Plans of Community Development Block Grant (CDBG), and Home Investment Partnerships (Home) Funds
