## PUBLIC HEARING REGARDING PROPOSED SUBSTANTIAL AMENDMENTS TO FY 2013-2017 CONSOLIDATED PLAN AND FY 2017 ACTION PLAN FOR HOME INVESTMENT PARTNERSHIPS PROGRAM FUNDS (HOME) – CARIBBEAN VILLAGE, LTD., OR RELATED ENTITY

The Housing and Social Services Committee (HSSC) will hold a public hearing on Monday, March 12, 2018 at 9:30 a.m., or the next regularly scheduled HSSC meeting if not approved, due to lack of quorum or deferral. Subsequently, the item will be considered for final action by the Board of County Commissioners (BCC), at the meeting on Tuesday, March 20, 2018 at 9:30 a.m., or at a meeting as determined by the BCC chair. Both meetings will be held inside Board of County Commission Chambers located on the second level of the Stephen P. Clark Center, 111 NW 1st Street, Miami, Florida 33128.

The purpose of the hearing is to give the **public an opportunity to comment** on the proposed Substantial Amendments to the FY 2013-2017 Consolidated Plan and FY 2017 Action Plan in order to allocate \$500,000.00 of a Home Investment Partnerships (HOME) funds to Caribbean Village, Ltd., or related entity, for the development of the Caribbean Villages elderly affordable housing project located on the corner of Caribbean Boulevard and SW 200th Drive, Miami FL 33157, in Commission District 9, represented by Commissioner Dennis C. Moss.

The public is invited to attend and comment.
