

IF YOU ARE A LICENSED CONTRACTOR OPERATING A COMMERCIAL VEHICLE

You are required to comply with Chapter 10 Section 10-4 of the Miami-Dade County Code which states:

Sec. 10-4. Persons without certificates representing selves as contractors; identification of vehicles.

(a) Any person or corporation not possessing a current certificate of competency and advertising in any newspaper, phone directory or other advertising media or who issues any card, advertising or device indicating to the public that he is a contractor, or who holds himself out as a contractor within Miami-Dade County, is in violation of this chapter; and a copy of such newspaper, telephone directory, or other advertising making such assertion shall be prima facie evidence in court, or in any other proceeding authorized by this chapter, that the person is purported to have the capacity to act as a contractor.

(b) Contractors conducting their contracting business within Miami-Dade County shall identify all trucks used in the furtherance of their business by use in the transporting of materials, equipment or employees to a job site, excepting a truck owned by an employee which truck is only used for private transportation or in carrying employees' personal tools and personal equipment necessary to fulfill their job tasks. Contractors shall place on the sides of the vehicle in a permanent manner, identification of the contractor's name and their certificate number; in letters and numerals not less than three (3) inches in height. Exception are those vehicles rented by a contractor from a commercial vehicle rental agency for a period of less than one (1) month; such trucks are plainly marked with the name of the lessor in letters and numerals not less than three (3) inches in height.

(c) Anyone who advertises in any newspaper, telephone directory, or other advertising medium for contracting to do any work covered by the provisions of this chapter shall include in all such advertising the permanent certificate of competency number from the certificate of competency required as a prerequisite under the provisions of this chapter. Failure to include this permanent certificate of competency number in all such advertising as evidenced by a copy or transcript of the subject advertisement shall constitute a violation of the chapter subject to the penalties provided herein.

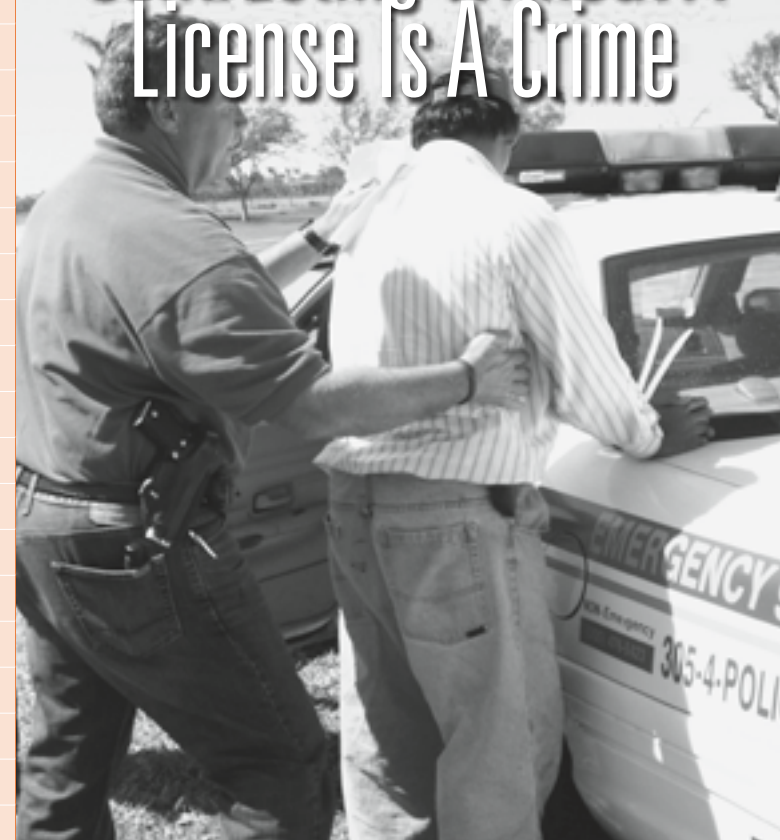

Why Should I Become A Licensed Contractor?

CONTRACTING WITHOUT A LICENSE IS A CRIME.

Unlicensed contracting may be charged as a first degree misdemeanor up to a third degree felony; punishable as provided in Chapter 775.082 and 775.083, Florida Statutes.



IT IS ILLEGAL TO ADVERTISE CONSTRUCTION SERVICES WITHOUT A LICENSE.

Advertising services regulated by Chapter 10, Code of Miami-Dade County or Chapter 489, Florida Statutes, without proper certification is a misdemeanor.

YOU ARE SUBJECT TO ARREST AND INCARCERATION.

First degree misdemeanors may be punished up to one year of imprisonment. During the existence of a state of emergency declared by the Governor, felonies of the third degree may be sentenced up to five years of imprisonment.

UNLICENSED CONTRACTORS ARE BEING TARGETED

A fully staffed and dedicated police unit has been created to pursue and root out unlicensed contractor activity.

FACE FINES, PENALTIES AND ADMINISTRATIVE FEES.

Fines up to \$5,000.00 per count plus restitution and administrative fees may be levied against violators.

CUSTOMERS DO NOT HAVE TO PAY YOU.

Contracts entered into by an unlicensed contractor shall be unenforceable in law or in equity by the unlicensed contractor.

CANNOT WORK OPENLY; MUST CONCEAL ACTIVITIES.

Working after hours to hide from enforcement activities will eventually catch up to you. The investigators follow-up on cases and reports of unlicensed activity at all times, including weekends.

CANNOT OBTAIN INSURANCE.

Insurance companies recognize that unlicensed contractors represent too great a risk to insure at any price.

CANNOT LEGALLY OBTAIN PERMIT.

Applications for permits are only accepted from contractors holding a current certificate of competency and license in their respective field. All work performed without permits are deemed to be unsafe by the Florida Building Code.



HOW DO I BECOME A MIAMI-DADE COUNTY LICENSED CONTRACTOR?

Miami-Dade County issues more than 100 different types of contractor licenses in both personal and business categories. To obtain a new personal license from the Department, you must first submit an application and meet certain experience requirements as well as maintaining a level of financial responsibility. Examinations for certificates of competency and eligibility are offered once a month. The exams are open book and the required books for each exam category will be provided at the time of application. Exams are offered in English or Spanish and special accommodations can be made for those who have disabilities. Some categories of licensure require no examination.

Once you have obtained a personal certificate of eligibility or competence,



you are entitled to obtain a business license. To obtain a business license you must complete an application either as a sole proprietor, partnership, or a corporation. As a Qualifying Agent for a business, you must have a significant interest or financial interest in the entity you qualify as evidenced by the position as an officer or partner or principal stockholder in accordance with Section 10-6 (E) 5 of the Code of Miami-Dade County. Additionally, proof of liability insurance and workers' compensation insurance must be supplied to the Department's Contractor Licensing Section.
