# 2014 LUXURY LIMOUSINE SEDAN LICENSE LOTTERY

## **Application Instructions**

In accordance with the provisions of Section 31-603(b)(ii) of the Code of Miami-Dade County ten (10) Luxury Limousine Sedan Licenses will be issued to provide luxury sedan limousine service in Miami-Dade County.

Applicants must submit their application in person at the Department of Regulatory and Economic Resources (RER) located at 140 West Flagler Street, Suite 904 in downtown Miami. They must also present a photo I.D. and pay a non-refundable application fee.

It is the applicant's responsibility to familiarize themselves with the lottery guidelines. All applicants must meet the requirements of Section 31-602 of the Code of Miami-Dade County. The relevant portions of the Code are available for viewing at <a href="https://www.municode.com">www.municode.com</a>.

#### **APPLICATION**

- Complete and notarize application TYPE or PRINT neatly.
- Answer all questions COMPLETELY. Do not leave blanks. Incomplete applications will not be processed until completed. Applications that remain incomplete will be denied. Note: Use N/A if question is not applicable.
- Submit ORIGINAL application and keep a copy for your records. The Department will not provide photocopies of any applications.
- The last day to submit applications will be Tuesday, January 20, 2015 at 4:00 PM

The RER shall disqualify applicants who do not follow the above instructions from participating in the lottery.

## **LOTTERY FEES**

- \$170.00 processing fee and \$100 for each entry.
- Acceptable forms of payment are Credit Card (Visa or MasterCard only), Cashier Checks or Money Orders made payable to Miami-Dade County. <u>No personal or business checks will be</u> accepted.
- Payment is required at the time of submission, and is non-refundable. Applications submitted without the proper application fee will not be accepted.
