APPLICATION FOR TRANSFER OF FOR-HIRE LICENSE **INSTRUCTION SHEET**

Type or print neatly.

All questions must be answered completely. Do not leave blanks; note N/A if not applicable. Also, note that no application or attachments shall be accepted after 30 days of being completed, signed, or notarized.

☐ Signature of both the applicant and license holder must be notarized.
☐ Submit as attachment #1 Attach \$194.00 application fee, (Check or Money Order made payable to Miami-Dade County). Application fee includes a fee of \$24.00, to conduct a Florida Department of Law Enforcement (FDLE) criminal background check. Payments by credit card can be accepted in person at our office.
☐ Submit as attachment #2 (If transfer is in result of a sale) a copy of the written contract between the license holder and assignee, purchaser or transferee disclosing the terms and conditions of the proposed assignment, sale or transfer, including the amount of compensation which has been paid or is payable to the assignor, seller or transferor and any other consideration given or to be given to the assignor, seller or transferor in connection with the assignment, sale or transfer of the for-hire license.
☐ Submit as attachment #3 proof that the applicant has the right to work in the United States. (This can be a US birth certificate, passport, or permanent resident card).
☐ Submit as attachment #4 (FOR CORPORATE APPLICANST ONLY): Provide Articles of Incorporation
Additional Requirements:

- No for-hire license may be transferred if the licensed assignor, seller or transferor has any unsatisfied judgements and outstanding tort liabilities as provided in the Code which state: An assignment, sale or transfer shall not be permitted if an unsatisfied judgement is on file with Miami-Dade County against the licensed assignor, seller or transferor.
- Any lien or security interest in a for-hire taxicab license must be satisfied and recorded with DTPW, the Department of State UCC Bureau and the Clerk of the Circuit Court of Miami-Dade County
- When a for-hire license or stock in a corporation owning a for-hire taxicab license is distributed from an estate to a beneficiary by a court of law, the transferee shall submit to DTPW the court order directing the County to transfer the for-hire license to the beneficiary as provided in section 31-82 (r) (6) of the Code.

NOTICE: An applicant shall not be eligible for a for-hire license if he/she/it:

- 1. Has misrepresented or concealed a material fact on his, her or its application;
- 2. Is an alien who is not duly authorized to work by the immigration laws or the Attorney General of the United States:
- 3. Is a user of alcohol or drugs whose current use would constitute a direct threat to property or the safety of others;
- 4. Has pled nolo contendere, pled guilty, been found guilty or been convicted of a felony within the last five (5) years, regardless of whether adjudication has been withheld, unless his or her civil or residency rights have been restored;
- 5. Has pled nolo contendere, pled guilty, been found guilty or been convicted of any crime wherein a for-hire vehicle was employed whether or not adjudication has been withheld;
- 6. Has pled nolo contendere, pled guilty, been found guilty or been convicted or any felony, regardless of whether adjudication has been withheld, involving moral turpitude relating to sex, the use of a deadly weapon, homicide, trafficking in narcotics, violence against a law enforcement officer under §775.0823, Florida Statutes, or is a habitual violent felony offender under §775.084, Florida Statutes;
- 7. Has violated any condition, limitation, or restriction of a for-hire license imposed by the Director or commission where the Director deems the violation to be grounds for denial;
- 8. Was enjoined by a court of competent jurisdiction in Miami-Dade County from engaging in the forhire business or was enjoined by a court of competent jurisdiction with respect to any of the requirements of this chapter:
- 9. Has as a stockholder, officer, director, or partner of a corporation or partnership committed an act or omission which would be cause for denying a for-hire license to the officer, director, stockholder, or partner as an individual;
- 10. Failed to comply with the terms of a cease and desist order, notice to correct a violation or any other lawful order of the Director;
- 11. Does not have a place of business located in Miami-Dade, Broward or Palm Beach County, Florida;
- 12. Has any unsatisfied civil penalty or judgment pertaining to for-hire operations;
- 13. Has had a for-hire license issued by Miami-Dade County revoked;
- 14. Has within the last five (5) years pled nolo contendere, pled guilty, been found guilty or been convicted of any misdemeanor (regardless of whether adjudication is withheld) involving moral turpitude relating to sex; or
- 15. Has within the last ten (10) years pled nolo contendere, pled guilty, been found guilty or been convicted (regardless of whether adjudication is withheld) of any offense involving trafficking in narcotics. After said ten (10) year period, such person shall only be eligible if and when his or her civil or residency rights have been restored.

<u>Financial Interest</u> - An interest equated with money or its equivalent. Any person having a monetary interest in the license must be disclosed. Example: A person who owns shares in the license or any part of the license or is in the process of buying the license has a financial interest.

<u>Beneficial Interest</u> - Any person who derives a profit, benefit or advantage resulting from a contract with the license holder. This would include any person who benefits in some way through the license holder.

<u>Legal Interest</u> - This includes, among other things, an interest arising out of a contract. Any person who has entered into a contract relating to the purchase of the license (conditional sale) has a legal interest in the license.

Equitable Interest - This includes, among other things, a beneficiary in case of a license holders death or divorce. Spouses or other designated beneficiaries have an equitable interest in the license.
