

Subject: Goodwill Ambassadors for the Miami Neighbor "Hoodie" Rally

On Sunday April 1, 2012 Congresswoman Frederica Wilson and the family of Trayvon Martin will host a Miami Neighbor "**Hoodie**" Rally from 3 p.m. to 7 p.m., at the Bayfront Park Amphitheater, 301 North Biscayne Boulevard. The event will provide a platform for citizens to protest peacefully about this tragic, unfortunate loss.

Commissioner Barbara J. Jordan has requested the service of the Goodwill Ambassadors to assist with the rally. The County is seeking 30 volunteers to serve as Goodwill Ambassadors who will greet and serve as guides. Volunteers will be granted administrative leave as appropriate and in accordance with the established personnel policies. As such, for every two hour worked, one hour of administrative leave will be granted.
