

Subject: Park and Recreation Needs Assessment Survey
Public Meetings

In an effort to better understand the recreation interests and needs of Miami-Dade County residents the Parks, Recreation and Open Spaces Department will administer a countywide Park and Recreation Needs Assessment Survey that will measure a comprehensive range of resident usage, satisfaction, needs, unmet needs, priorities and other services. Approximately 8,000 surveys will be completed of a random sampling of households in neighborhoods across Miami-Dade County. Data collected as a result will be used to both inform and guide future planning, development and programming decisions made by the Department.

As such, four (4) public meetings were scheduled in an effort to provide residents with the unique opportunity to participate in the Park and Recreation Needs Assessment Survey planning process. Meeting locations were selected geographically (northeast, north central, west and south) so that all residents of the County would have an opportunity to participate if they choose. Residents were encouraged to attend and participate.

However, due to unanticipated crowds associated with early election voting at West Dade Regional Library and the possibility that some residents in the area were not able to attend the November 1, 2012 community meeting, a follow-up meeting has been scheduled by the Parks Department on Wednesday, November 28, 2012 at 7:00pm.

Attached, for your information, is a copy of the new public meeting advertisement, which will appear in the Neighbors Section of the local Miami Herald newspaper, on the County portal, calendar and the Park's Department web and Facebook page.
