Attached are the Full-time Employee Personnel Actions Reports for August and September 2012, as required by Resolution R-232-09. This report lists all the new hires, promotions, demotions, transfers, reclassifications (with associated fiscal impact), and terminations that occurred during these periods. Each vacancy was evaluated to confirm that it was operationally necessary to fill the position.

These reports include a significant number of layoff actions in the Community Action and Human Services Department which reflects the transition of the Head Start Program to the delegate agencies. We have confirmed that 106 of the 308 layoff terminations listed on both reports were hired by the delegate agencies. Also, 14 of the employees impacted by the transition elected to retire from County service.
