Subject: Report on Historic Preservation Activities



Per Ordinance 14-65, this memorandum will be placed on the next available Board of County Commissioners meeting agenda.





MIAMI-DADE COUNTY OFFICE OF HISTORIC PRESERVATION

Historic Preservation is an important county function that helps communities maintain a higher quality of life by preserving its cultural heritage and historic resources for future generations, establishes a context for future development, encourages green building practices and sustainable growth, and provides economic development through heritage tourism.

In conjunction with the Miami-Dade County Historic Preservation Board (HPB), the Office of Historic Preservation (OHP) preserves and protects Miami-Dade County's cultural, historical, architectural, and archaeological resources through historic designations, site management and monitoring, public education, and by finding creative solutions and economic incentives for historic preservation efforts.

The Miami-Dade County Historic Preservation Board is a 13-member quasi-judicial board that is appointed by the Board of County Commissioners. The Board meets monthly, and is comprised of professionally diverse members including engineers, architects, historians, biologists, and attorneys. The Board is tasked with designating archaeological and historic sites, reviewing plans for significant renovations to historic structures, and weighing in on important historic preservation issues around the county through resolutions. They also host an annual historic preservation awards ceremony to recognize individuals and organizations for excellence in preservation, education, or advocacy. Additionally, the OHP and HPB serve as the historic preservation office and board for all unincorporated areas of the County and for the 24 municipalities that do not have their own historic preservation ordinance or staff.

COUNTYWIDE PRESERVATION ACTIVITIES

Environmental Reviews

The Miami-Dade Public Housing and Community Development Department (PHCD) is required to perform Environmental (Historic) Reviews on every property older than 50 years for which they provide funding. The Office of Historic Preservation (OHP) performs these reviews for PHCD on an as-needed basis.

Ad-Valorem Tax Exemption Applications

OHP processes the Ad-Valorem tax exemption applications as submitted, and monitors construction throughout the process.


Heritage Park Signage and Audio Tours

OHP is working with Parks Recreation and Open Space (PROS) to create smart phone/audio tours throughout some of the Heritage Parks, including historic interpretive signage consistent with PROS' approved way-finding systems.



Certificates of Appropriateness

OHP works with owners of historically designated properties and the Regulatory and Economic Resources Department (RER) Building Code Support Division to review proposed alterations and ensure that the historic integrity of the resources remains intact.



DISTRICT 1 PRESERVATION ACTIVITIES

OPA-LOCKA CITY HALL

OHP is assisting in the oversight and plan reviews for the restoration of the historic Opa-Locka City Hall. The project is a recipient of County General Obligation Bond (GOB) funding as well as State grant funding. OHP is serving as a liaison between the State and project architects, as well as reviewing the project for compliance with GOB regulations.

DISTRICT 4 PRESERVATION ACTIVITIES

BAY HARBOR ISLANDS

The Town of Bay Harbor Islands received a State grant to perform a historic resources survey in 2005/2006. In 2009, the Miami-Dade County Historic Preservation Board (HPB) directed OHP staff to perform an independent survey on the East Island. OHP is currently working on a survey that would update both of these previous efforts and will coordinate with the Town as this effort continues.

GREYNOLDS PARK

OHP is assisting Parks, Recreation, and Open Space (PROS) with a number of projects within Greynolds Park, including new pathways in the Camp Greynolds section, a new playground, and the new park entry and parking enhancements. OHP's involvement includes approving the plans for compliance with historic requirements, coordinating material selections with contractors, and site monitoring.

NORTH BAY VILLAGE

At the request of Village officials, OHP met with the Vice-Mayor and Town Manager to discuss potential preservation incentives. The Village may want OHP to perform more in-depth historic survey.

SURFSIDE

SURF CLUB (9011 Collins Avenue) – ongoing collaboration with developers and architects to ensure that the Surf Club restoration is in compliance with the approved plans and conditions.

SEAWAY VILLAS (9149 Collins Avenue) – property is going through the designation process (owner initiated.)





DISTRICT 7 PRESERVATION ACTIVITIES

ARDEN “DOC” THOMAS HOUSE

This historic structure located near the heart of South Miami currently serves as the headquarters for the Tropical Audubon Society. OHP recently filed the report that was approved by the Federal government to list the site in the National Register of Historic Places. OHP is finalizing the follow-up documents for submittal to the State/Federal government.

MacFARLANE HOMESTEAD HISTORIC DISTRICT RESTORATION PROJECT

Through a grant from Public Housing and Community Development (PHCD), OHP is restoring and rehabilitating three historic wood-frame houses in what was an original Bahamian settlement near Grand Avenue and US 1. This is the only historic district in Coral Gables listed in the National Register of Historic Places. The home restorations also meet the standards for providing affordable housing.

The owner requested OHP to perform a site visit and determine if the building is eligible for local designation. The site visit has been performed and preliminary research is being gathered for designation purposes.


DEERING ESTATE AT CUTLER ARCHAEOLOGICAL SURVEY

RICHMOND NAVAL AIR STATION/ADMINISTRATION BUILDING




