- DATE:** October 28, 2013 to November 15, 2013
- TIMES:** Varied
- LOCATION:** Miami-Dade Public Safety Training Institute

- CURRICULUM:** This course is designed to provide basic tactical training for aspiring SRT applicants. The course curriculum includes daily strenuous physical training, advanced firearms training, and basic introductory instruction in tactics commonly used to mitigate or quell volatile high-risk situations.

- EQUIPMENT:** Outside agency personnel will be required to provide their own weapons, ammunition, and all required equipment. An equipment list will be provided to all eligible applicants at the conclusion of the Physical Skills Assessment/Firearms Qualification on September 27, 2013.
- ENROLLMENT:** Applicants must submit an approved Miami-Dade Public Safety Training Institute training course application (MDPSTI-24) to the Course Coordinator. Additionally, outside agency applicants are directed to submit a memorandum, via their chain of command, to the Special Patrol Bureau, Tactical Operations Section, Special Response Team (SRT) Captain Gregory Dohring, explaining their desire to attend this course.
- All applicants must attend the 8-hour Physical Skills Assessment and Firearms Qualifications on Friday, September 27, 2013, at 7:00 a.m.,** at the Miami-Dade Public Safety Training Institute. Outside agency personnel wishing to participate in this training must have written approval from their agency and must also pass the listed skills assessment and firearms qualification.

Physical Skills Assessment Information

<u>Run</u>	1.5 miles in 12 minutes or less
<u>Bench Press</u>	Body weight plus 25 lbs. (1 repetition)
<u>Pull-Ups</u>	3 full extension pull-ups wearing a 25 lb. weight (chin must go completely over the bar)
<u>Sit-Ups</u>	50 sit-ups within 2 minutes (arms across the chest and elbows must clear the knees)
<u>Push-Ups</u>	50 push ups within 2 minutes
<u>Grip Strength</u>	125 lbs. (Strong hand)
<u>Swimming</u>	50 yard continuous swim (wearing long sleeve shirt, long pants, and boots/shoes)
<u>Water Tread</u>	15 minute active water tread (wearing long sleeve shirt, long pants, and boots/shoes)
<u>Firearms</u>	
<u>Handgun</u>	Score at least a 90% (43 of 48 rounds) in the 5 scoring ring of the target on the handgun qualification course
<u>Shotgun</u>	Score at least a 90% (65 of 72 rounds) in the 2, 3, 4, & 5 scoring area of the target on the shotgun qualification course
