## Rules & Regulations:

**Boats must designate their check-in point but can return to any of the participating marinas. Winners will be determined according to check-in point.**

Winners will be determined by the combined weight of the three largest fish within the species of **dolphin, wahoo, black-fin tuna, and kingfish.**

- Lines in at 7:00 a.m. Lines out at 3:00 p.m.
- Scales open at 2:00 p.m. Queue for Scales close at 5:00 p.m.
- All tournament boats must show their number to the designated check-in person by 5:00 p.m. to be in the check-in line. The last team in line will be handed an "end of the line" sign by the check-in person. No team may break line or leave and return to the line.
- All fish caught must meet federal, state, and local regulations.
- All teams are subject to a polygraph if tournament committee deems necessary.
- All boats must remain in U.S. waters, no Bahamian or Cuban waters.
- IGFA Rules Apply.
- Junior Anglers must be 12 years and younger, must have birth certificate or passport available if questioned.
- Junior Angler Prizes will be determined based on combined weight of three largest fish of any fish that meets federal, state, and local requirements.
- Marina managers will be weigh masters.
- Protests must be in writing with **\$100 processing fee** to competition committee prior to the commencement of the award ceremony.
