The list below contains zoning items which may be of interest to your immediate neighborhood.

1. **PALMETTO PRESBYTERIAN CHURCH AND T-MOBILE SOUTH LLC (06-187)**

Location: 6790 SW 56 Street, Miami-Dade County, Florida (2.08 Acres)

The applicants are requesting an unusual use to permit a wireless supported service facility within a cross addition to an existing bell tower of an existing religious facility, and ancillary equipment. Also requesting to permit a modification of a condition of a previous resolution to allow the applicant to submit revised plans indicating a proposed stealth wireless supported service facility to be located within a cross addition to an existing bell tower of an existing religious facility and ancillary equipment to be located within the building.

2. **LOIS NULMAN (06-195)**

Location: 9046 SW 112 Court, Miami-Dade County, Florida
(45' X 68')

The applicant is requesting a modification of a plan approved on a previous resolution to allow the applicant to submit new plans showing a covered terrace addition to the rear of the previously approved cluster residence.

3. **LOMAR INVESTMENT, LLC (06-289)**

Location: 10631 SW 88 Street, Miami-Dade County, Florida
(1.11 Acres)

The applicant is requesting to waive the zoning regulations permitting a wall sign for each street frontage to permit two wall signs with no street frontage where none is permitted, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
