

## FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for Miami-Dade County repairs to Storage Shed G due to damages in Hurricane Irma (DR-4337-FL PW-07196). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for projects under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 6, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Floodplain:** Project location is located in the AE Zone, otherwise 100-year floodplain, per the Miami-Dade County FIRM map # 12086C0318L, dated 09/11/2009.
- Proposed Work and Purpose:** Miami-Dade County will make repairs to Storage Shed G to repair fascia, soffit, flat roofing, drain pipe elbows, and exterior light fixtures. Minimization against future flood damages has been met as the facility is located above the Base Flood Elevation.
- Project Alternatives:** The alternative that has been considered is the no action alternative. This alternative is not feasible as the area will remain vulnerable to flood risk, including property damage. Alternate locations were not considered as relocating the facility outside of the floodplain is not feasible. Storage Shed G supports port action within Miami-Dade County and relocation may adversely impact social or economic resources for the community.
