License Requirement - At the time of Bid and pursuant to the requirements of Section 10-3 of the Code of Miami-Dade County, Florida and this RPQ and Contract Documents, the Bidder must hold a valid, current, and active State and/or Miami-Dade County contractor's license from the County's Construction Trades Qualifying Board, which is consistent with the requirements of the Scope of Work. Specialty contractors shall subcontract with a qualified contractor, as required by chapter 10, for any work, which is incidental to their specialty but is specified in the aforementioned Code as being work other than that of the certified specialty.

SCOPE OF WORK:

The Contractor shall furnish all materials, labor, services, supervision, tools, equipment, and all other items necessary to repair a portion of the bulkhead walls at the south cruise area located at Miami-Dade County Seaport Department. The project is comprised of, but not limited to: install a grout injection system into the subsurface to secure void spaces; mill and overlay the work area; provide pavement markings; and any supportive ancillary tasks to successfully complete all phases of the project. All work shall be performed in accordance with the Contract Documents.

LICENSES AND MINIMUM QUALIFICATIONS:

1. Must demonstrate experience working on or within ten (10) feet of sea walls and bulkheads.
2. Must acquire insurance as required by the Longshore and Harbor Workers' Compensation Act
3. Must demonstrate experience in deep drilling and pressure grouting operations.
4. Must demonstrate past performance in bulkhead construction, tie-rods, and sheet piling systems
5. Must demonstrate experience in subsurface underwater repairs and/or construction.
